<p><u>Glen Morgan</u> reported via the portal (Fri, 21 Jul 2023 at 11:55 PM) To whom it may concern,</p> <p>Once again, it has come to my attention that Lisa Brown, in her current campaign for the Mayor of Spokane, has violated Washington State's campaign finance laws (RCW 42.17A). The details of these additional violations are as follows:</p> <p>1) Attempt to conceal major donor contribution for many months (Violation of RCW 42.17A.235 & .240)</p> <p>Every time I check in on this campaign, it seems they keep finding more ways to break the law and it is clear that they certainly don't care about sternly worded letters from the PDC "reminding" them to follow the law. This time, when I took the time to check on this campaign, sure enough, as predicted, they chose to break the law again. This is why I have classified this campaign as one of the "frequent flier" lawbreakers, clearly laughing at the law and believing it only was written for the little people, not the well-funded political insiders like Lisa Brown.</p> <p>For example, it now appears this campaign concealed a major contribution of \$1,000 from one of their well-heeled contributors for many months (See PDC C3 Report #110159994, attached). You will note that this contribution was made way back in March, but wasn't reported until just a few days ago. This was supposed to be reported 4 months ago, but this campaign chose to conceal the truth from the public once again.</p> <p>Additionally, for staff convenience, you can link to this report here: https://apollo.pdc.wa.gov/public/registrations/campaign-finance-report/110159994</p> <p>6) Willful attempt to conceal true sponsorship of campaign video (Violation of RCW 42.17A.320)</p> <p>See link: https://www.youtube.com/watch?v=52d5Qg5vBeU</p> <p>This video ad was required to have the full mailing address of the sponsor as part of the sponsor ID statement, but this was not included, of course. Seriously, does this campaign believe the law applies to them at all? This is the second time recently this campaign has willfully committed THIS EXACT SAME VIOLATION.</p> <p>Every time I glance at this well-funded, political insider campaign, I find more violations. There is no excuse here. This is a very experienced veteran politician who has fossilized into the political</p>

landscape for many years now. There is no excuse for just willfully violating the law so repeatedly unless they have no concerns that the law will ever be equally applied to them. The PDC might be able to convince this campaign that willfully and sloppily violating Washington State's campaign laws is not approved activity, even for a former cabinet appointee for the Inslee administration.

Despite Lisa Brown's behavior indicating otherwise, the law is not intended to just be applied to the little people like the rest of us out here suffering the consequences of poor political leadership – it also should be applied to the people like Lisa Brown who apparently consider themselves above the law.
