It has come to my attention that Redmond City Council candidate Tara Van Niman has violated Washington State's campaign finance laws (**RCW 42.17A**) during their failed 2021 campaign for council position 6. The details are as follows:

1) Acceptance of Illegal overlimit contributions (Violation of RCW 42.17A.405(2))

This is a blatant violation and easy to identify. I've attached copies of the relevant C3 report proving this violation.

As PDC staff know well, and as all political candidates running for office in Washington State have been made aware, there are limits to the campaign contributions they can accept.

There were only two candidates for this Redmond City Council seat for which Tara Van Niman was running. This means there was no primary. **Despite this fact, Tara Van Niman accepted at least \$500** in illegal overlimit contributions explicitly designated for a Primary election that never happened. Failed candidate Tara Van Niman, at the time they accepted this illegal overlimit contribution, already knew this because the cash from the maxed out donor came in AFTER the election was lost. Tara Van Niman has had years to resolve this illegal behavior, and apparently has willfully chosen to ignore the law and keep the illegal cash.

Tara Van Niman must refund or forfeit these illegal contributions immediately in order to at least pretend to comply with Washington State's campaign finance laws, as tardy as this compliance might be.

Specifically, the illegal overlimit contributions are as follows and clearly designated as "Primary" campaign contributions:

On 6/27/21 this campaign received \$500 – from already maxed out donor "Sheri Nichols" – PDC C3 report # 110062946 (see attached) Please note – this C3 report was filed 6 months late – AFTER the election was over and it was well known that this was an illegal overlimit contribution.

Please note, this same donor also donated another \$1,000 to the Tara Van Niman campaign (**See PDC C3 report # 110029107** attached). Technically, it is the late reported "Primary" election

designated contribution of \$500 which must be refunded or forfeited from this campaign in order to come back into some type of compliance with Washington State's campaign finance laws. Let me know if you need anything else from me.
