<p><u><a href="#">Glen Morgan</a></u>  reported via the portal  (Thu, 3 Aug 2023 at 1:03 AM)  To whom it may concern,</p> <p>It has recently come to my attention that the Yes to East King County PUD PAC has violated Washington State campaign finance disclosure laws per <b>RCW 42.17A</b>. The violations are as follows:</p> <p><b>1) Acceptance of illegal overlimit anonymous contributions (Violation of RCW 42.17A.220(4))</b></p> <p>Based on the information reported by this campaign to the PDC, it appears that this campaign has accepted \$738.94. in anonymous contributions (See <b>PDC C3 report #110079688 attached for reference</b>). This campaign has only reported raising enough money to accept up to \$300 in anonymous contributions as the statute so clearly details in <b>RCW 42.17A.220(4)</b>, so at least \$438.94 must be forfeit to the State Treasurer of this secretive anonymous contribution.</p> <p>Let me know if you need additional information on this one.</p> <p>Best Regards,</p> <p>Glen Morgan</p>
