To whom it may concern,

It has come to my attention that Irene Bowling, perennial failed political candidate has violated Washington State's campaign finance laws (**RCW 42.17A**) with her 2018 failed campaign for the Washington State Senate in the 35th LD. The specific violations are as follows:

1) Attempt to conceal critical details of in-kind contributions from the public (Violation of RCW 42.17A.240)

I'm not sure how I missed this one in the past. I was stuck at the airport waiting for hours for my repeatedly delayed airplane to leave, so I thought I would surf the PDC website, and I discovered this blatant violation. I had to fill the time, so I thought I might as well assist the PDC in the endless effort to ensure compliance with Washington State's campaign finance laws by the lawbreakers who refuse to comply.

It appears that Irene Bowling, perennial failed political candidate has squandered vast sums of campaign contributions in addition to violating **RCW 42.17A.240** when it comes to how they have concealed critical information and details about in-kind contributions from the public. Specifically, I want to draw attention to the PDC's own website recommendations for how PACs and campaigns need to report this information. See original link here:

In-Kind Contributions | Washington State Public Disclosure Commission (PDC)

Specifically, I want to draw attention to the PDC's specific requirements of reporting:

"In-kind donations that are not incidental must be fully reported in Part 1 of Schedule B to the C-4 with the following details:

- the date the contribution was received;
- the name and full address of the contributor:

- if the in-kind contribution is a good or service purchased from a vendor, include the name and address of the vendor;
- a brief description of the contribution;
- its fair market value;
- the cumulative total this contributor has given for the primary or general election, whichever applies;
- a designation whether this contribution is for the primary or general election; and
- if the contributor is an individual who has cumulatively given more than \$250 to the campaign, including both primary and general contributions, identify the individual's employer (by name, city and state) and occupation."

While I might have missed some of the in-kind contributions where this failed candidate also failed to provide these legally required details, I have attached a partial list of at least 100 specific in-kind contributions as examples of where this failed political candidate chose to violate the law instead of complying with it. I've attached this as a PDF and as an Excel file for staff convenience. Please note, I have linked the respective C-4 report corresponding to the illegally reported in-kind contribution in the far right column for easy verification by staff and as a correctional resource for Irene Bowling.

Obviously, Irene Bowling must comply with the law, regardless of her personal feelings about that law or how annoying compliance with that law probably seems to her (for clarification, I am using the pronoun "her" because I see no indication that she has rejected this pronoun usage, but in case she has modified her pronoun descriptor or now identifies as some other category of gender requiring a less common pronoun, feel free to me know so that future complaints can be modified to properly address her pronoun selection). Clearly, this is a lot of critical information that has been concealed from the public, and many people will be carefully watching (including me) to confirm that she finally becomes compliant with this very clear law and the obvious requirements it mandates for everyone — including Irene Bowling.

2) Failure to accurately or honestly report in-kind contribution of campaign signs from previous political campaign for different office. (Violation of RCW 42.17A.240)

The PDC provides very clear and helpful guidance on their website, linked here under "How to report use of old campaign signs":

How to report use of old campaign signs | Washington State Public Disclosure Commission (PDC)

The PDC clearly states the Bowling campaign must report the following (quote from the above link on the PDC's website):

"Once the fair market value is established, you have a few options for reporting it:

- Transfer as an in-kind contribution. In the last campaign, work backwards from the last contribution received to see who donated up to the amount that would cover the new fair market value of the used signs. Seek written permission from those individuals to move the value of the signs to the new campaign. Then, in the new campaign in ORCA, enter the signs in Transactions>Contributions>In-kind Contributions. The contributor will be the candidate's previous campaign, and, in the description, you would enter "TRANSFER WITH PERMISSION SIGNS."
- 2. Candidate pays the previous campaign. The candidate, using the new "fair market value" of the used signs could pay the previous campaign that amount. Then, in the new campaign, report the signs under Transactions>Contributions>In-kind Contributions. The contributor would be the candidate, and, in the description, you would enter something to the effect of "SIGNS PURCHASED FROM 2017 CAMPAIGN."
- 3. New campaign purchases the signs. This purchase would be reported in the new campaign under Transactions>Expenditure>Monetary Expenditures. The vendor would be, for example, "CANDIDATE NAME 2017 CAMPAIGN." You would then deposit these funds into the old campaign, which would require that campaign to file a C-3 and C-4."

Unfortunately, despite this easy to find and well-reasoned data provided to the Bowling campaign, it appears they chose to violate the law instead of following any of these options explained above.

Evidence for this misuse of campaign signs from a previous campaign can be found linked below on a Bowling campaign C4 (**PDC C4 Tracking # 100866496** attached), in an expenditure to vendor "Blackstar" on 10/12/18 for \$162.75 called "**coverup stickers for signs.**"

While this campaign clearly did "coverup" their lawbreaking by ordering these stickers for signs from the previous failed campaigns by Irene Bowling from previous years – nowhere are the quantities of these signs defined or explained. For the record, this campaign also failed to indicate how many stickers they purchased either, so there is no way for the public to know how many illegally transferred signs this campaign used from previous failed campaigns for different offices. Obviously, this is just another example of obvious lawbreaking by this campaign, and I'm sorta surprised I missed this in the past.

3) Total failure to report and describe expenses, the illegal concealment of required information from the public (Violation of RCW 42.17A.240, WAC 390-16-037, WAC 390-16-205)

Since the Bowling campaign was already openly willing to flagrantly violate Washington State's campaign finance laws with her failed 2018 campaign, I wondered whether the this campaign had concealed other critical information from the public during this failed campaign. Plus, I had enough time before my plane was due to leave the terminal, I might as well check it out.

It turns out the Bowling legal violations were not confined to the above examples, For example:

On a variety of this campaign's C4s they failed to provide specific details that are required to be reported to the public from various vendors as explicitly required by **WAC 390-16-037**. A small sampling of these violations are as follows:

- A. On C4 Report (**PDC Tracking # 100858363**) this campaign spent \$309.59 to vendor "Engage Campaigns" for "Facebook Boost and Ads." **Clearly this campaign must report how many ads this expense covered**, which they chose not to do.
- B. On C4 Report on 11/14/18 (**PDC Tracking # 100934399**, see attached) this campaign spent \$325.22 to vendor "Engage Campaigns" for "Texting GOTV." **How many texts were sent? This is a simple number to report as every vendor must report these details, yet the Bowling campaign decided to conceal this critical information from the public.**
- C. On C4 Report on 11/8/18 (PDC Tracking #100934399, see attached same as above), this campaign claims to have spent \$816.37 to vendor "Sophia Blamey" for "travel expenses up to date." This is concealing the truth about these travel expenses. What were these mystery "expenses?" Did they include bar-tabs for alcohol, a friendly stop at the local pot shop, or a visit to a strip club en route to the final campaign party? This is completely inadequate information to report to the public and it only serves to conceal the truth about what these final expenses really were for.

D. On C4 Report on 11/23/18 (**PDC Tracking #100934399**, see attached, same as above), this campaign claims to have spent \$5,445.83 with vendor "Mercury Direct" for "final mailing piece before general." However, no legally required details were provided for how many "mail pieces" were sent. This is the specific example used in **WAC 390-16-037 (example B)**, yet this campaign ignored the law and decided to just violate it instead.

E. On C4 Report on 10/03/18 (**PDC Tracking # 100866496**, see attached), an in-kind contribution by Karen Fraser (another fellow prolific campaign finance violator – see **PDC Enforcement Cast #23122**) for a total of \$354.74 for "mailing to 35<sup>th</sup> District in support of Irene." As you can clearly see, no details on the quantity of the mailing is provided for the public as clearly required by law (**See WAC 390-16-037**).

Clearly, it isn't hard to find many violations of this law committed by this campaign. The Bowling campaign had extraordinary resources which were perfectly adequate for them to use for even marginal levels of compliance with Washington State's campaign finance laws. It shouldn't be too much to expect well-funded campaigns rolling in campaign cash like this one to follow the law.

It is my sincere goal that this well-funded, failed political candidate can eventually become compliant with Washington State's campaign finance laws and the very reasonable, clear expectations that are so transparently provided to candidates like this to help them follow the law. I'm hoping this complaint helps Irene Bowling get closer to this goal and the attainment of this goal which I am sure is just around the corner, someday.

Years may have passed since this politician lost this political race, but it is never too late to come clean and start following the law for a change.

Let me know if you need additional information on this one. I feel like I barely scratched the surface here, but I'm hoping to get a few more complaints filed before I catch my next flight.
