It has recently come to my attention that Jeanette Twitty has violated Washington State campaign finance disclosure laws per **RCW 42.17A** in her current campaign for Tacoma Port Commissioner. The violations are as follows:

## 1) Acceptance of illegal overlimit anonymous contributions (Violation of RCW 42.17A.220(4))

Based on the information reported by this campaign to the PDC, it appears that this campaign has accepted \$700.00 in anonymous contributions (See **PDC C3 report #110161580 and also # 110154871 attached for reference)** This campaign has only reported raising enough money to accept up to \$500 in anonymous contributions as the statute so clearly details in **RCW 42.17A.220(4)**, so at least \$200 must be forfeit to the State Treasurer of this secretive anonymous contribution. The state can then proceed to waste these funds just like they typically waste most of our tax dollars. Regardless, this is the only legal remedy I can see for their lawbreaking in this case.

Mr. Morgan,

The Public Disclosure Commission (PDC) completed its review of the complaint you filed on July 11, 2021, against Jeanette Twitty, a candidate for Tacoma Port Commissioner in 2021. The complaint alleged that the 2021 Jeannette Twitty Campaign (Campaign) may have violated: (1) RCW 42.17A.220 by receiving & depositing anonymous contributions in excess of the statutory limitations; and (2) RCW 42.17A.240 by failing to disclose the candidate filing fee and provide the required expenditure details on Summary Full Campaign Contribution and Expenditure reports (C-4 reports) for political advertisements sponsored by the Campaign.

PDC staff reviewed the allegations listed in the complaint; the applicable statutes, rules, and reporting requirements; the Monetary Contributions reports (C-3 reports), amended C-3 reports, C-4 reports and amended C-4 reports filed by the Campaign, and the email responses from the Campaign, to determine whether the record supports a finding of one or more violations.

Based on staff's review, we found the following:

- On June 7, 2021, Jeannette Twitty filed a Candidate registration with the PDC declaring her candidacy for Port Commissioner for the Port of Tacoma, Position #2, selecting the Full Reporting option and listing Arlene Nation as Treasurer. Ms. Twitty was a first-time candidate for public office in 2021 and finished third in the August 3, 2021 primary election.
- On July 5, 2021, the Campaign timely filed a C-3 report disclosing \$1,100 in total contributions had been received and deposited on July 1, 2021. The C-3 report disclosed that a \$500 monetary contribution was received from Freddie Thomas on June 28, 2021, and a total of \$600 in anonymous monetary contributions had been received on June 29, 2021.
- On July 28, 2021, the Campaign filed an amended C-3 report disclosing the same \$1,100 in total contributions including the \$500 contribution received from Mr. Thomas, but the amended information re-classified the \$600 in anonymous contributions and attributed those funds to two contributors. The amended C-3 report information disclosed that a \$360 monetary contribution was received from Mattie Fails on June 23, 2021, and a \$240 monetary contribution was received from John Miller on July 1, 2021.
- On July 12, 2021, the Campaign timely filed a C-3 report disclosing \$1,300 in total contributions had been received on July 10, 2021 and deposited on July 12, 2021.

- The C-3 report disclosed the receipt of six itemized contributions of more than \$25 totaling \$900, and \$400 in anonymous monetary contributions were received and deposited into the Campaign bank account.
- On July 28, 2021, the Campaign filed an amended C-3 report disclosing the same \$1,300 in total contributions including the six itemized contributions, but the amended information reclassified the \$400 in anonymous contributions and attributed those funds to three contributors. The amended C-3 report information disclosed that a \$200 monetary contribution had been received from Marla Roberts, a \$100 monetary contribution was received from Norma Washington, and another \$100 monetary contribution was received from David Hartman. The amended information disclosed that all three contributions were received on July 10, 2021.
- On July 28, 2021, the Campaign filed an amended C-4 report covering the period May 20 through 31, 2021, disclosing that a \$216 in-kind contribution had been received from Ms. Twitty on May 20, 2021 for the candidate filing fee.
- On August 8, 2021, the Campaign filed three amended C-4 reports covering the period May 20 through July 26, 2021, disclosing the required expenditure details for: (1) several expenditures made to Charles Thrower reimbursing him for campaign-related expenses he made for political advertisements using personal funds; and (2) several expenditures made to Xpress Signs for yard signs.
- Arlene Nation, Campaign Treasurer stated that the campaign originally reported some of the contributions received at fundraising events as "anonymous" because the contributors failed to "include complete information in the contribution envelopes provided." She stated that some of the contributor (or remittance) "envelopes had a complete name in some cases and a first name in other cases. However, Jeannette knew all the people who showed up at the fundraisers, so she was able to get the remaining information once she found out that the limit on anonymous contributions was \$300."
- The Campaign indicated that once Ms. Twitty had "collected the contributor information we were able to update that information away from anonymous contributions" and file the amended C-3 reports with the correct contributor information.

Jeannette Twitty is a first-time candidate and upon notification of the reporting discrepancies, her Campaign timely filed amended C-3 and C-4 reports as requested by staff to bring her Campaign back into compliance.

Based on these findings staff has determined, in this instance, the allegations concerning the initial disclosure of anonymous contributions, and the failure to accurately disclose one expenditure and include the proper description for other expenditures, does not amount to a violation warranting further investigation or any enforcement.

However, pursuant to WAC 390-37-060(1)(d), Jeannette Twitty will receive a formal written warning concerning the incorrect classification of monetary contributions as anonymous contributions, and the failure to timely disclose a Campaign expenditure, and expenditure details as required for political advertising.

The formal written warning includes staff's expectation that Jeannette Twitty will, in the future, timely and accurately file PDC reports and disclose contributions and expenditures as required by law. The Commission will consider the formal written warning in deciding on future Commission action if there are future violations of PDC laws or rules.

Based on this information, the PDC has dismissed this matter in accordance with RCW 42.17A.755(1). If you have questions, please contact PDC Compliance Officer Kurt Young by e-mail.

This campaign has only reported raising enough money to accept up to \$300 in anonymous contributions as the statute so clearly details in RCW 42.17A.220(4), so at least \$300 must be forfeit of this secretive anonymous contribution.

#### 2) Failure to report any campaign expenditures (Violation of RCW 42.17A.235, .240)

This campaign has only filed one C4 with the PDC so far, and there are no reported campaign expenditures for expenses this campaign has incurred so far. For example, this candidate has had a website for a while now. See the campaign website at <a href="www.twittyforportcommissioner.com">www.twittyforportcommissioner.com</a>. The expense of reserving the url, hosting the website, or producing the website is not reported. Additionally, no filing fee has been reported on any expenditure reports.

It isn't too much to ask candidates for public office to comply with the Washington State campaign finance laws. This candidate has a Treasurer, and they should know these rules.
