Complaint Description

Glen Morgan reported via the portal (Tue, 8 Aug 2023 at 10:49 AM)

To whom it may concern,

It has come to my attention recently that the Thurston County Democratic Women (TCDW) PAC has, unfortunately, decided to violate Washington State's campaign finance laws (**RCW 42.17A**). The details are as follows:

1) Failure to list the vendor and the address of the vendor for in-kind contributions, therefore concealing from the public the true source of these contributions (Violation of RCW 42.17A.240, RCW 42.17A.235)

When an individual or entity makes a donation of goods or services to a political committee so that the committee may attempt to sell these goods or services to others in exchange for money, this is an in-kind contribution.

I want to draw attention to the PDC's own website recommendations for how PACs and campaigns need to report this information.

Specifically, I want to draw attention to the PDC's specific requirements of reporting:

"In-kind donations that are not incidental **must** be fully reported in Part 1 of Schedule B to the C-4 **with the following details:** the date the contribution was received; the name and full address of the contributor; **if the in-kind contribution is a good or service purchased from a vendor, include the name and address of the vendor**; a brief description of the contribution; its fair market value; the cumulative total this contributor has given for the primary or general election, whichever applies; a designation whether this contribution is for the primary or general election; and if the contributor is an individual who has cumulatively given more than \$250 to the campaign, including both primary and general contributions, identify the individual's employer (by name, city and state) and occupation."

This committee has failed to do this on numerous occasions over the past few years. For both staff and the lawbreaker's reference, **I will detail a handful of the deficient examples**, so that the obvious lawbreaking can be hopefully corrected in the future to prevent the need to file additional maintenance and compliance complaints like this one:

- Violation Example #1 \$28.52 on 8/29/2021 (PDC C4 Report # 110067070) for "champagne" donated by Susan Herring. As the PDC rules so clearly state above, it is a legal requirement for this PAC to report where the champagne was purchased and the address of the original supplier of that champagne. The public has a right to know, and this PAC has a duty to report it, per PDC explicit rules quoted above.
- **Violation Example #2 & #3** (**PDC Report # 110118174**) there were two crystal clear, textbook examples of violations on this report. The first was for \$60.99 on 8/23/2022 for "Reimbursement for Wine" to "Deborah Pattin," but again no details on where the wine was actually purchased the original source of the wine, the name of the original vendor or the address where that wine was

acquired. The other textbook example of a violation on this same report was a \$344.61 for "Reimbursement for food for event" to Meren Gadman, which again lacks the legally required details – what food? What event? And what address and name of the original provider of this mystery food? I've attached a copy of this C4 since there is more than one violation included on the same report – just for staff reference.

I did not attach a spreadsheet of these violations because there were not enough to merit that level of effort, but it is still worth correcting the legally required reporting deficiencies of this PAC.

2) Failure to timely report contributions or expenditures (Violation of RCW 42.17A.235, RCW 42.17A.240)

This violation, I believe is far more serious than the one I have outlined above. I was under the mistaken belief that I have brought up this concern adequately in the past, but it might be more effective for this committee to start filing their reports in a timely manner. In a distressingly, all too often repeated pattern, this committee files reports late (97 reports, to be exact). Many of these reports have been filed weeks or months late. In an effort to help PDC staff properly categorize the lateness of these reports, my attached spreadsheets provide a color coded reference category for helpful sorting:

- Red (Extremely late harming the public's right to know) 54 extremely late reports up to 146 days late. There really is no excuse for these
- Orange (Concerningly late delaying the public's right to know) 23 concerningly late reports up to 13 days late. Again, not legal and not following the law
- **Yellow (Sloppily late delayed reporting)** 21 sloppily late reports up to 3 days late. These could just be mistakes, sloppy bookkeeping, and written off as typical fumbling around by the treasurer, however, I'm including them in this report so that PDC staff can put this general widespread pattern of lawbreaking in context.

Again, I've provided both an Excel file and PDF version of the same file for ease of staff and the lawbreaker's reference as they re-educate themselves with Washington State's campaign finance laws and are reminded that these laws apply to them as well. They are not exempt from them as much as they might want to pretend these laws don't matter.

Some notes on documenting these violation:

Again, as I strive to provide the best data possible both for efficiency of staff and the lawbreakers I have identified, every report can be direct linked to the URL in the far right hand column. The date the report was due is provided and the actual date it was finally sent to the PDC and the total number of days late for those reports is included for ease of PDC staff research effort, and to quantify the significance of these violations both individually and cumulatively with the obvious problems caused by not informing the public about the truth of their activities in a timely manner.

The Thurston County Democratic Women PAC: A history of problems:

Unlike the Thurston County Democrats who have extensive experience in widespread lawbreaking and campaign finance violations (See PDC Enforcement Case #15417, PDC Enforcement Case #11660, and Thurston County Superior Court Case #17-2-00972-34), the Thurston County Democratic Women

PAC has only received on formal Reminder from the PDC in recent years (See **PDC Enforcement Case #47222**, see attached reminder letter). Unusually, this original enforcement case against the Thurston County Democratic Women PAC was not initiated by one of my complaints, but by a former member of the Thurston County Democrats.

Unfortunately, it appears that the PDC reminder in that case (encouraging this PAC to be less sloppy with their record keeping and more timely in their filing) seemed to have the opposite intended effect, and **compliance at this PAC has actually declined.** Perhaps the PDC staff can help guide them back into the fold of following the law once again because clearly **the previous reminder only encouraged them to break the law even more since that time.**

Feel free to let me know if you need anything else. Obviously, I haven't been keeping up on some of these local committees as well as I should have, so I will resolve to pay more attention in the near future, and I'm trying to finish my Thurston County PAC and candidate review this week while I am taking a break camping (I have hotspot access, so nothing better than surfing the PDC reports while by a campfire, using a solar powered battery charger – Go Green!)

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on February 15, 2019. Your complaint alleged that the Thurston County Democratic Women, a continuing political committee, may have violated RCW 42.17A.205 for failure to re-register on an annual basis to maintain mini-reporting status in 2019; WAC 390-16-125 for exceeding mini-reporting limitations without written approval from the PDC in 2018; and RCW 42.17A.235 for failure to timely and accurately file Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contribution and Expenditure reports (C-4 reports), disclosing contributions and expenditures undertaken by the Campaign after exceeding mini-reporting limitations in 2018 and failure to re-register as a mini-reporting committee in 2019.

PDC staff reviewed your allegations; the applicable statutes, rules, and reporting requirements; the response provided by the Thurston County Democratic Women; the applicable PDC reports filed by Respondent; and queried the Respondent's data in the PDC contribution and expenditure database, to determine whether the record supports a finding of one or more violations.

Based on staff's review, we found the following:

- The Thurston County Democratic Women is a political committee which has been registered under the mini-reporting option provided by WAC 390-16-105 through WAC 390-16-125, which allows a committee to not file C-3 and C-4 reports provided they adhere to a series of requirements such as allowing inspection of books before an election, accepting no more than \$500 from any single contributor, and raising and spending no more than \$5,000 during a calendar year. WAC 390-16-105.
- The mini-reporting option requires a continuing political committee to file a new Political Committee Registration (C-1pc), "between January 1st and January 31st for each year in which the committee intends to use the mini reporting system. Failure to file a new registration during January will automatically terminate the committee's entitlement to use the mini reporting system until such time as a new C-1pc is filed." WAC 390-16-115.
- The Thurston County Democratic Women failed to submit a C-1pc as required by WAC 390-16-115, and their mini-reporting status was terminated until such time as a new C-1pc was filed.

- The Thurston County Democratic Women filed a C-1pc on February 27, 2019, selecting the mini-reporting option.
- The Complaint contained a treasurer's report from July-August 2018 that provided no evidence to support the allegation that the Thurston County Democratic Women raised and spent more than \$5,000 in a calendar year, nor to support the allegation that they received and retained any contribution from a single contributor exceeding \$500 in the aggregate.
- The Thurston County Democratic Women attest that they did not raise or spend more than \$5,000 in 2018, and that they did not receive and retain any contribution from a single contributor exceeding \$500 in the aggregate.
- The Thurston County Democratic Women have no prior found violations of PDC laws or rules.

Based on these findings staff has determined that, in this instance, failure to timely file a C-1pc to select the mini-reporting option for calendar year 2019 does not amount to an actual violation warranting further investigation.

PDC staff is reminding the Thurston County Democratic Women about the importance of timely registering in each calendar year to utilize the mini-reporting option. Staff expects that the Thurston County Democratic Women will familiarize themselves with the rules around mini-reporting contained in WAC 390-16-105 through WAC 390-16-125 to ensure consistent and timely compliance with PDC statutes and rules.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).
