<p>Angrob206</p> <p>Thu, 17 Aug 2023 at 7:52 PM</p> <p>In relation to contributions, as stated on the PDC website and explained within RCW 42.17A.405, “Any contributions received for an election in which the candidate is not on the ballot or a write-in candidate must be returned”. The Snohomish County Sheriff candidates were not included in the primary. So, the max contribution limit is \$1,200 for the general election.</p> <p>Looking at the campaign contributions for Adam Fortney for Snohomish County Sheriff, their campaign contributions show \$4,600 in contributions which exceed contribution limits. Please see attached photo for a breakout of the contributors that exceeded the contribution limit (information is from August 8, 2023). It does not appear the Fortney campaign has returned any of exceeded contributions.</p>
What impact does the alleged violation(s) have on the public?
The Adam Fortney for Snohomish County Sheriff campaign is retaining contributions which exceed contribution limits. By doing so, the campaign’s total contributions are possibly being overstated to the public.
