1. The issue identified as (A) in the complaint states that your campaign accepted multiple contributions from Billy Dunn then reattributed some of the total contribution to a company that in your report Billy Dunn is listed as the owner.

I looked up Joes Glass Company (UBI 603-396-884) and found that the Governors of the business are Joe and Christy Dunn. Billy Dunn is not listed on the business registration. **Are you sure he is the "owner" as indicated in the report of his contribution?** 

No I am not sure. This one is fairly simple. I had no idea it was my responsibility to look up business registrations to find the actual owners or registrants of a donor. To be honest, I wouldn't even know how to do this. I thought if someone from the community told me they owned a business and their business would like to donate, I accepted them at their word. Now I know better and Sarah and I are in the process of correcting all of this.

And did you receive a check from the company, Joes Glass Company, or did you reattribute one of the checks provided by Billy Dunn to Joes Glass Company?

I believe it was reattributed but I thought we were doing the right thing. This is now in the process of being corrected.

2. The issue identified as (B) in the complaint states that your campaign accepted multiple contributions from Gregory Jantz then reattributed some of the total contribution to a company that is owned by Gregory Jantz. I looked the company up and it is registered under The Center for Counseling and Health Resources, Inc (UBI 601-007-082) with Governors Lafon and Gregory Jantz. Did you receive a check from the company, A Center A Place of Hope, or did you reattribute one of the checks provided by Gregory Jantz to A Center A Place of Hope?

Same answer as above. I thought we were good the way we did it but now I know different because of Sarah coming on the campaign. It is being fixed.

3. For issues identified as (C) and (D) please review the allegations and provide an explanation of what your campaign did in relation to the reporting of these donations and if there are any corrections that need to be made.

I hired a professional treasurer and ordered a full audit a few weeks ago. All of this has either been addressed or being addressed. I think I have been open and transparent with all of this, and I have clearly acknowledged where I have made a mistake and I have proven my steps in correcting all of it. It just takes some time.
