Complaint Description

Glen Morgan reported via the portal 9 days ago (Wed, 16 Aug 2023 at 5:01 PM) To whom it may concern,

After reviewing some recent PDC filings, it has come to my attention that the Franklin County Democrats have committed significant violations of Washington State's Campaign Finance laws (RCW 42.17A). The details are as follows:

1) Failure to timely report contributions or expenditures (Violation of RCW 42.17A.235, RCW 42.17A.240)

Oddly enough, I found a political committee in Washington State that for some reason I never caught their violations before now. I feel like I'm making up for past mistakes and oversights by filing this complaint now.

I reviewed the history of late reports for this PAC, which requires a fairly extensive comparison between when the reports are due and when they were actually filed. A distressing pattern of behavior is uncovered by doing this simple research. It takes a lot of time, but once you've done it a few times, it gets more efficient every time you look. Clearly it might be more transparent for this PAC to start filing their reports in a timely manner even a few times a year. In a distressingly, all too often repeated pattern, this committee files reports late (166 reports, to be exact). Many of these reports have been filed weeks, months, and impressively sometimes over a year late, and many of them (I have highlighted these in red for PDC Staff to easily review) concealed significant financial transactions over \$1000 in totals for these egregiously late illegal reports. In an effort to help PDC staff properly categorize the lateness of these reports, and the shocking sloppiness of this organization's operation (how the heck did I miss this one before?), my attached spreadsheets provide a color-coded reference category for helpful sorting. Please keep in mind, so far, this is close to the worst violator I have uncovered for this type of violation in the state this month:

Red (Extremely late – harming the public's right to know) 153 extremely late reports – up to 445 days late (over a year!). There really is no excuse for these extremely late reports to have concealed so much critical information from the public for so long. The sheer volume of these violations indicates no serious effort to comply with the law and in fact a concerted effort to mock the very concept of campaign finance reporting from the beginning.

Orange (Concerningly late – delaying the public's right to know) one concerningly late report – this was 10 days late. Again, clearly not legal and not following the law. Surprising a bit that there was only one in this category.

Yellow (Sloppily late – delayed reporting) 12 sloppily late reports – up to 3 days late. These could just be mistakes, sloppy bookkeeping, and written off as typical fumbling around by the treasurer, however, I'm including them in this report so that PDC staff can put this general widespread pattern of lawbreaking in proper context. If this shady group had only committed this type of violation, despite the strict liability requirements of RCW 42.17A, I probably wouldn't file this complaint, but clearly this is just further evidence of no effort to really pay attention or comply with the law.

Again, I've provided both an Excel file and PDF version of the same file for ease of staff and the lawbreaker's reference as they re-educate themselves with Washington State's campaign finance laws and are reminded that these laws apply to them as well. They are not exempt from them as much as they might want to pretend these laws don't matter.

I will reiterate here, for PDC staff edification – most of his PAC's history they seem to be concealing the truth from the public most of the time for months and even over a year in many cases. This is unacceptable lawbreaking even under the current regime's leniency for lawbreakers. I am sorta amazed this one escaped my notice in the past

Some notes on documenting these violation:

Again, as I strive to provide the best data possible both for efficiency of staff and the lawbreakers I have identified, every report can be direct linked to the URL in the far-right hand column. The date the report was due is provided and the actual date it was finally sent to the PDC and the total number of days late for those reports is included for ease of PDC staff research effort, and to quantify the significance of these violations both individually and cumulatively with the obvious problems caused by not informing the public about the truth of their activities in a timely manner.

I want to apologize to the PDC for missing this obvious and egregious level of lawbreaking by this PAC. There is no excuse for not filing this complaint earlier. Clearly, I will add this group to my list of frequent flier lawbreakers for regular review since they seem so intent on breaking the law in the future. I'm optimistic that with real consequences for this PAC this time, perhaps that can create some incentive for them to start following the law for a change in the future. PDC staff should keep in mind that if this PAC is so willing to botch all their historic filings, then the real question is how many "current" filings are accurate or flawed? Based on this documented recent history – probably most of them. It might be worth filing subpoenas on the bank records for this organization so that staff can verify the lack of compliance with primary sources since it is obvious you can't trust the documents they file to be accurate or timely. The public has been done a grave disservice here for years now by this crew.

2) Failure to list the vendor and the address of the vendor for in-kind contributions, therefore concealing from the public the true source of these contributions (Violation of RCW 42.17A.240, RCW 42.17A.235)

When an individual or entity makes a donation of goods or services to a political committee so that the committee may attempt to sell these goods or services to others in exchange for money, this is an in-kind contribution.

I want to draw attention to the PDC's own website recommendations for how PACs and campaigns need to report this information.

Specifically, I want to draw attention to the PDC's specific requirements of reporting:

"In-kind donations that are not incidental must be fully reported in Part 1 of Schedule B to the C-4 with the following details: the date the contribution was received; the name and full address of the contributor; if the in-kind contribution is a good or service purchased from a vendor, include the name and address of the vendor; a brief description of the contribution; its fair market value; the cumulative total this contributor has given for the primary or general election, whichever applies; a designation whether this contribution is for the primary or general election; and if the contributor is an individual who has cumulatively given more than \$250 to the campaign, including both primary and general contributions, identify the individual's employer (by name, city and state) and occupation."

This committee has failed to do this for both auction items and regular in-kind contributions.

For both staff and the lawbreaker's reference, I will detail a handful of these types of violations. Hopefully the obvious lawbreaking can be more efficiently spotted and hopefully corrected in the future to prevent the need to file complaints like this one:

Violation Example #1 & #2 - \$70.73 on 6/24/2023, and another \$104 (PDC Report #110158489 attached), the true identity, address, and information on where the original inkind contributions were acquired were not provided, despite the crystal-clear legal requirement to do so.

Violation Example #3 - \$50.00 on 10/21/2022 (PDC Report #110123746 attached), the true type of gift card, address from where this gift card was purchased, etc was not provided, again, despite the crystal-clear legal requirements to do so.

While this specific violation category is probably not as egregious as the fact this Political Committee has failed to timely file very many of their C3 or C4 reports over the past few years, it is still worth noting and correcting. Once a committee like this goes down the lawbreaking path, they rarely just restrain themselves to one type of lawbreaking activity.

Regardless, I hope this complaint helps assist PDC staff in their investigation into the inability of this crew to follow the law, and perhaps some type of sanctions can help them do better in the future. There is always hope that compliance is somehow possible in the near future.
