<p>Glen Morgan</p> <p>Thu, 17 Aug 2023 at 12:18 PM</p> <p>To whom it may concern,</p> <p>It has recently come to my attention that the Washington State Progressive Caucus PAC has egregiously violated Washington State's campaign finance laws (RCW 42.17A) and continues to do so today.</p> <p>1) Total concealment of all political activities including contributions and expenditures (Violation of RCW 42.17A.235, RCW 42.17A.240, and appears to be knowingly violating these laws – it appears that RCW 42.17A.750 & RCW 42.17A.755 would be most appropriate for enforcement purposes)</p> <p>In addition to the additional violations detailed later in this complaint, I want to point out for the record, that despite the fact this PAC has been and is currently active in Washington State politics, they are refusing to file any reports for the last few years. Yet, if you look at their website, you can currently donate to their PAC. You can do this yourself at the following link on their website:</p> <p>Washington State Progressive Caucus — Donate via ActBlue</p> <p>If they attempt to take this donation page down from their website or attempt to further conceal their ongoing illegal activity, I have also attached screen grabs clearly showing this Dark Money PAC collecting cash and raising funds for political purposes and to influence elections – as clearly spelled out on this page and in the attached screen grabs from today (8/17/2023).</p> <p>I will concede, for the record, it is always possible this crew is just lying and they are stealing these funds donated to them for other purposes, and perhaps this would be their defense for their long history of lawbreaking, but I will leave it to them to concoct their own story for their actions.</p> <p>2) Massive illegally late reporting of the majority of this Dark Money, Secretive PAC's expenditures and a concerted effort to conceal the truth about their actions from the public for years (Violation of RCW 42.17A.235, RCW 42.17A.240)</p>

In light of the first allegation I documented above, this one is no surprise, but it is relevant because it demonstrates a consistent pattern of behavior and a clear indication that this PAC has no intention to follow the law, comply with the law, and they never have. As I have done in a variety of recent cases, I have attached a spreadsheet specifically detailing all of these types of violations committed by this PAC in the past few years. Please keep in mind, that in light of the first allegation above, it is likely this is just the tip of the iceberg, and nothing currently on file with the PDC from this secretive Dark Money PAC is true or accurate anyway. I'm just doing the best I can with the illegal actions already documented by this crew:

I will point out for PDC staff reference and guidance, that based on past behavior, by this group, it might be more effective for staff to pull bank records and attempt to reconcile the actual account balances of this secretive PACs to their C4 reports and see just how dishonest this group has been over the past five years. Maybe someday this committee to start filing their reports in a timely manner. In a distressingly, all too often repeated pattern, this committee files reports late (134 reports, to be exact – just within the statute of limitations – far more if you look back further, of course). Many of these reports have been filed weeks or months late. In an effort to help PDC staff properly categorize the lateness of these reports, my attached spreadsheets provide a color coded reference category for helpful sorting:

Red (Extremely late – harming the public's right to know) 112 extremely late reports – up to 309 days late. There really is no excuse for these extremely late reports other than to conceal from the public the truth about what this secretive Dark Money PAC is doing – when they grudgingly finally file some reports months later -the elections are over. A terrible pattern of corrupt and illegal behavior.

Orange (Concerningly late – delaying the public's right to know) 10 concerningly late reports – up to 17 days late. Again, not legal and not following the law

Yellow (Sloppily late – delayed reporting) 12 sloppily late reports – up to 2 days late. These could just be mistakes, sloppy bookkeeping, and written off as typical fumbling around by the treasurer, however, I'm including them in this report so that PDC staff can put this general widespread pattern of lawbreaking in context.

Again, I've provided both an Excel file and PDF version of the same file for ease of staff and the lawbreaker's reference as they re-educate themselves with Washington State's campaign finance laws and are reminded that these laws apply to them as well. They are not exempt from them as much as they might want to pretend these laws don't matter or apply to Dark Money PACs as long as they pretend to be "Progressive."

Some notes on documenting these violations:

Again, as I strive to provide the best data possible both for efficiency of staff and the lawbreakers I have identified, every report can be directly linked to the URL in the far right hand column. The date the report was due is provided and the actual date it was finally sent

to the PDC and the total number of days late for those reports is included for ease of PDC staff research effort, and to quantify the significance of these violations both individually and cumulatively with the obvious problems caused by not informing the public about the truth of their activities in a timely manner.

3. Failure to timely update C1pc to include current officers, essentially keeping the true officers of this PAC secret from the public (Violation of RCW 42.17A.205(2))

The current committee registration can be found here, and it was last filed in February of 2020:

The committee's current website indicates there are different officers now, and this should be updated on the PDC's website and in the C1PC filing as well. I've attached screen grabs of their current website in case they decide to hide more information from the public and the PDC.

Obviously, this secretive Dark Money PAC has a history of breaking the law, they are currently breaking the law, and it appears unlikely they ever will comply with the statute, but PDC staff has the unenviable task of trying to figure out what this gang is actually doing right now. Whatever it is, it certainly isn't "Progress," but it is clearly illegal.

Let me know if you need me to provide more details on this group's lawbreaking. I'm sure there is much more to find here.
