<p>Glen Morgan</p> <p>Fri, 18 Aug 2023 at 12:39 AM</p> <p>To whom it may concern,</p> <p>It has come to my attention, mainly because I started to pay attention, that the Grays Harbor Democrats, as usual, are breaking Washington State's campaign finance laws (RCW 42.17A). The specific violations are detailed below:</p> <p>1) Attempting to conceal the truth about political activity from the public by waiting weeks, months, or until the election is over to report what they did or who funded them (Violation RCW 42.17A.235, RCW 42.17A.240)</p> <p>I realize this allegation doesn't surprise anyone who has paid any attention to this shady group over the past decade or so. This group was caught breaking this exact law last time (PDC Enforcement Case #26838 and was fined \$900 at the time, but who cares when it isn't your money?). Anyway, since I know this crew enjoys breaking the law, I thought I would revisit their activities once again and help the PDC address this troubled group and their wayward ways.</p> <p>As has been my habit lately, I've attached a spreadsheet with color-coded sorting for the egregiously late reports (red), the problematic late reports (orange), and the sloppily late reports (yellow). However, for additional clarity, I also highlighted all the late reports that were filed AFTER this PAC paid the last \$900 fine to the PDC in early 2020 (based on my original 2017 complaint against this crew).</p> <p>Clearly, despite the Statement of understanding (attached for staff reference), and despite the \$900 fine, and despite the fake promise to do better, this group is just off the rails once again, not reporting much on time, and holding quite a bit back from the public.</p> <p>Again, I've provided both an Excel file and PDF version of the same file for ease of staff and the lawbreaker's reference as they re-educate themselves with Washington State's campaign finance laws and are reminded that these laws apply to them as well. They are not exempt from them as much as they might want to pretend these laws don't matter or apply to them.</p> <p>Some notes on documenting these violations:</p> <p>Again, as I strive to provide the best data possible both for efficiency of staff and the lawbreakers I have identified, every report can be directly linked to the URL in the far-right</p>

hand column. The date the report was due is provided and the actual date it was finally sent to the PDC and the total number of days late for those reports is included for ease of PDC staff research effort, and to quantify the significance of these violations both individually and cumulatively with the obvious problems caused by not informing the public about the truth of their activities in a timely manner.

2) Failure to properly identify as a sponsored committee (Violation of RCW 42.17A.005(47)(b)(i), WAC 390-16-011A)

The Grays Harbor Democrats (2023) PAC has received 100% of its funding from only one source, and this is the \$1,000 contribution from the 24th LD Democrats in January (See C3 PDC Report # 110132765, attached for staff reference). No other contributions were made. They were involved in the primary elections earlier this year, and they should change their name to “Grays Harbor Democrats PAC, sponsored by the 24th LD Democrats PAC” in order to conform to the law.

The law is very clear, as WAC 390-16-011A clearly states:

“A sponsored political committee must amend its C-1pc sixty days before an election in which it participates if the committee's name on its most recently filed C-1pc does not include at least one current sponsor.”

This political committee failed to comply with the law and correct it’s C1PC documents to properly reflect that it was a wholly sponsored PAC with most of its funding coming from one guy. This was a flagrant effort to conceal the truth, and it should be corrected now.

I will concede the possibility that this PAC is simply concealing the truth from the public as has been their habit for years (see allegation #1 above), but based on their reporting, and if they want to pretend to follow the law for now – they clearly need to correct their name to reflect their sponsorship status as a PAC sponsored by another PAC.

3) Failure to accurately describe expense, and the illegal concealment of required information from the public. (Violation of RCW 42.17A.240, RCW 42.17A.235 & WAC 390-16-037)

Once I realized this PAC would so egregiously violate the law with such carelessness, laugh off the PDC fine imposed the last time I caught them breaking the law, and they were so blatantly willing to violate the law, I started to look closer. It turns out this odd group has failed to follow Washington State’s Campaign Finance laws as they apply to the reporting of expenditures frequently (of course). Here are a few specific examples of failing to follow the law. These are clear and explicit violation of WAC 390-16-037, Example A:

On September 25, 2020 – This PAC claims to have used vendor “Alpha Media Group” and reportedly spent \$1,088 and another \$1,088 – on “Radio Ad for General Election” but no

clarification or specifics (How many ads? What station? Over what period of time were the radio ads run? This is clearly legally required and specified in WAC 390-16-037, example A (See PDC Report #101006188, attached for Staff Reference).

On October 14, 2020 – This PAC claims to have used vendor “Capital City Press Inc” and reportedly spent \$634.52 on “Biden/Harris Yard Signs” but no specifics on how many? This is legally required and specified in WAC 390-16-037, example B (See PDC Report #101011833, attached for Staff Reference).

On October 8, 2020 – This PAC claims to have used vendor “Jodesha Broadcasting” and reportedly spent \$2,120 for “Radio ads for endorsed candidates for entire month of October,” but again failed to detail how many ads? which stations? Which candidates? Again, this is legally required and specified in WAC 390-16-037, example A (See PDC Report 101066188, already attached for Staff Reference).

It got even worse in 2022 – On just one C4 report (See PDC Report #110131414, attached for Staff Reference), This PAC claims they spent \$1,992 on “Radio Advertising, Radio Advertising for General Election” with vendor “Jodesha Broadcasting” and also they claimed to have spent \$2,000 for “Radio Advertising: Radio ads for General Election” supposedly with vendor “Alpha Media, “ and they also claimed to have spent \$607.62 on “printing literature, fliers, postcards, etc” with vendor “Samuel Vini” (which is suspicious since “Samuel Vini” is probably not the actual printer, so this could be a bonus violation where the true source of these fliers is concealed), and also they claimed to have spent \$1,008.00 on “Radio Advertising: Radio Advertising” supposedly with vendor “Alpha Media.” In every one of these reported transactions, the critical and legally required details are excluded – “how many ads? Over what dates? On which stations? For which candidates?” Again, this is legally required and specified in WAC 390-16-037, Example A, and then again in Example B for the “fliers, literature” expenditure.

Cousin Vini shows up again in PDC Report #110131413 (attached for staff reference) for another \$498.22 for nebulous “literature” again no details.

In a particularly sneaky and dishonest manner, this crew tried to conceal from the public the cost of their past lawbreaking. Looking at PDC Report #100963567 (attached for PDC staff reference), this group tried to hide the \$900 fine they were forced to pay to the State as part of their settlement with the PDC in early 2020. They called this fine in the description “26838” which is laughably dishonest rather than calling it a “PDC fine” or “legal settlement for breaking Washington State’s campaign finance laws” or something like this, they tried to conceal the truth of the expenditure – this should be corrected on this report and refiled for the public to easily and transparently know the truth.

I’m sure there are more violations like this over the past few years, but it gets boring to give too many details, and besides, they are likely to have concealed so many transactions, that we might as well wait for the currently missing reports to appear in the future and then just catch them breaking the law again at that time.

The Grays Harbor Democrats – A sad and disturbing history of lawbreaking

As I mentioned at the beginning of this complaint, one reason I wanted to check in with this crew was to see if they had possibly started following the law after I exposed their lawbreaking in the past. It is sorta like checking on your drug addict cousin who claims he has come clean. You hope it is true, but you can't be too surprised when you find out they are just doing the same thing all over again. This group appears addicted to breaking the law.

Again, I filed a complaint against this same organization in 2017, which resulted in PDC Enforcement Case #26838 (weirdly enough, the respondent wasn't properly identified as "Grays Harbor Democrats" in the Respondent column, so this enforcement action is harder to discover, but that is something that IT should probably correct at the PDC themselves). Anyway, for some reason, the PDC took three years to resolve that case, during which time this PAC continued to break the law. Eventually, they were forced to pay a \$900 fine to the state for their lawbreaking. As part of that settlement, they promised to go and sin no more. However, clearly, they have chosen to break the law regardless.

I'm not sure if you can truly help people who are addicted to lawbreaking like this, but you can make a serious attempt to get them to change their ways and sanction them with additional fines now. Maybe that will help them get back on the straight and narrow. Until that time happens, however, I will need to remain vigilant and watching this PAC and their lawbreaking ways.

It has come to my attention that the Grays Harbor County Democratic Central Committee has habitually and willfully committed frequent and multiple violations of **RCW 42.17A**.

1) Failure to file accurate, timely C3 and C4 reports. (Violation of RCW 42.17A.235)

State law requires that candidates and committees file frequent, accurate reports of contributions, expenditures, in-kind contributions, and debt. Unfortunately, the Grays Harbor County Democratic Central Committee has failed on numerous occasions to do this.

2) State law prohibits committees from accepting more than \$300 worth of anonymous contributions annually, or 1% of the total amount raised, whichever is greater. RCW 42.17A.220 (4). State law also establishes that candidates must return contributions that exceed the contribution limits contained in RCW 42.17A.405 within 10 days of receipt. RCW 42.17A.405, RCW 42.17A.110, WAC 390-16-312.

In 2016, the Grays Harbor Democratic Party reported having received \$4383.85 in anonymous contributions, while they reported having received less than \$30,000 in total contributions. \$811.85 was reported in unexplained anonymous contributions and \$3572 appears to have been incorrectly reported from the sale of hamburgers.

Depending on how you view their reporting, either \$511.85 or \$3272 was accepted in excess of the applicable \$300 anonymous contribution limit.

Either \$511.85 or \$3272 was collected illegally by the Committee when it should have been sent to the State Treasurer's Office.

3) State law requires that the committee treasurer preserve books of account, bills, receipts, and all other financial records of the campaign or political committee for not less than five calendar years following the year during which the transaction occurred. (Violation of RCW 42.17A.235 (6)).

State law further requires that the committee treasurer maintain a list of all individuals contribution no more than twenty-five dollars in the aggregate from any one person during the election campaign. **RCW 42.17A.240(2)(c).**

On information and belief, the Grays Harbor County Democratic Central Committee has failed to maintain financial records for a period of five calendar years following the year during which the transaction occurred. Specifically, I believe that they have failed to maintain a list of individuals contributing no more than twenty-five dollars in the aggregate from any one person.

4) Failure to electronically file in 2016 and 2017. (Violation of RCW 42.17A.245)

State law requires that political committee that expended five thousand dollars or more in the preceding year or expects to expend five thousand dollars or more in the current year shall file all contribution reports and expenditure reports required by this chapter by the electronic alternative provided by the commission under RCW [42.17A.055](#).

Unfortunately, despite having raised over \$5000 in 2016, the Grays Harbor Democratic Central Committee failed to file electronically in 2017. They are still filing reports by hand, in violation of state law. They must immediately begin filing electronic reports for 2017.

Additionally, I believe that they had the expectation of raising over \$5000 in 2016, and their failure to file electronic reports (even after they surpassed the \$5000 threshold) constitutes a violation of state law.

The PDC should investigate the possibility that the Grays Harbor County Democratic Central Committee committed the above violations maliciously, which would be a class C felony per **RCW 42.17A.750 (2)(c)**. If the PDC determines that is the case, they should refer the case to the Attorney General's office for criminal prosecution immediately. As noted in the letter to Glen Morgan, the PDC will not be conducting a more formal investigation into these allegations or take further enforcement action in this matter since the Grays Harbor County Democratic Central Committee (Committee) completed a Statement of Understanding (SOU) and paid a \$900 civil penalty acknowledging violations of (1) RCW 42.17A.245 by failing to electronically file in 2016 and 2017 and (2) RCW 42.17A.220(4) for accepting over limit anonymous contributions in 2016 and (3) RCW 42.17A.235 and .240 by failing to timely and accurately file Monetary Contribution (C-3) reports and Summary Full Campaign Contribution and Expenditure (C-4) reports disclosing contributions and expenditures undertaken by the Committee for calendar years 2016, 2017 and 2018.

Based on this information, the PDC has dismissed this matter in accordance with RCW 42.17A.755(1).

The Public Disclosure Commission (PDC) completed its review of the complaint you filed October 13, 2017. Your complaint alleged the Grays Harbor Democratic Central Committee violated (1) RCW 42.17A.235 by failing to timely and accurately file Monetary Contribution (C-3) reports and Summary Full Campaign Contribution and Expenditure (C-4) reports disclosing contributions and expenditures, (2) RCW 42.17A.405 by failing to return over limit contributions within 10 days of receipt, (3) RCW 42.17A.240 by failing to properly maintain a list of contributors and (4) RCW 42.17A.245 by failing to electronically file in 2016 and 2017.

PDC staff reviewed your allegations; the applicable statutes, rules, and reporting requirements; the response from Jamie Nichols, Chairperson of the Grays Harbor Democratic Central Committee; and data in the PDC contribution and expenditure database, to determine whether the record supports a finding of one or more violations.

As it was alleged “on information and belief”, PDC staff did not investigate the allegation of RCW 42.17A.240 for failing to properly maintain a list of contributors.

Based on staff’s review we found the following:

- The Grays Harbor Democratic Central Committee disclosed \$29,845.51 in contributions and \$24,096.88 in expenditures during the 2016 election, \$17,605 in contributions had been received and \$13,751 in expenditures made in 2017 and \$19,603 in contributions received and \$14,051 in expenditures made in 2018.
- Most of the Committee’s spending from 2016 – 2018 was party-building activities, fundraising and administrative costs, however in 2016, the Committee made \$4,000 in contributions to candidates.

Election year 2016: On January 30, 2017, the Committee filed C-3 and C-4 reports for the 2016 election year. These reports were between 23 and 206 days late.

Election year 2017: On September 16 and 17, 2019 the Committee filed C-3 and C-4 reports for election year 2017. The late reports were filed between 616 and 981 days late.

Election Year 2018: On September 17, 2019 the Committee filed C-3 and C-4 reports for election year 2018. The late reports were filed between 250 and 584 days late.

Jamie Nichols, Committee Chairperson, stated “I believe it is in the best interest of the Grays Harbor Democrats to resolve this as soon as possible. As a newly elected Vice Chair of the party, with no prior knowledge of this violations before the acceptance of this position, I hope we can work together in order to ensure the proper filing of past paperwork.”

During the 2016 calendar year, the Committee disclosed the receipt of anonymous contributions on line 1a of the 2016 C-4 reports. In an addendum, the Committee provided an “explanation for line item 1d” however Nichols noted this was for items listed on line 1a. In 2016, the Committee was not able to provide information for \$1,197.85 in anonymous contributions. On July 2, 2020, the Committee amended its 2016 C-3 reports, noting the anonymous contributions were a low-cost fundraiser.

The Committee completed a Statement of Understanding (SOU), paid a \$900 civil penalty in accordance with WAC 390-37-143 (Brief Enforcement Penalty Schedule), acknowledging violations of RCW 42.17A.245, RCW 42.17A.220(4), 42.17A.235 and .240 listed above in accordance with the Penalty Schedule adopted by the Commission for Brief Enforcement Hearings set forth in WAC 390-37-143. The \$900 penalty assessed in this matter resolves the allegations listed in your complaint.

Based on the above findings, the SOU, and the fact the Committee has timely filed its 2020 reports, staff has determined that, in this instance, this matter does not warrant further investigation. The PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).

(Printed Name of Treasurer/Committee Officer) that the Grays Harbor County Democratic

Central Committee violated:

(1) RCW 42.17A.235 and .240 by failing to timely and accurately file Monetary Contribution (C-3) reports and Summary Full Campaign Contribution and Expenditure (C-4) reports disclosing contributions and expenditures undertaken by the Grays Harbor County Democratic Central Committee (Committee) for calendar years 2016, 2017 and 2018 as detailed below; and (2) RCW 42.17A.245 by failing to file C-3 and C-4 reports electronically:

Election year 2016: On January 30, 2017, the Committee manually filed on paper C-3 and C-4 reports for July 1 through December 31, 2016, disclosing \$12,334 in contributions received and \$18,061 in expenditures made for party building activities and \$4,000 in monetary contributions made to candidates for public office and one political party committee. The party building activities included the costs of the monthly meeting; costs for precinct, legislative district, and county party convention; and fundraising proceeds from running the Burger Booth at various events including at the Grays Harbor County Fairgrounds, and other local festivals.

The contributions made during the 2016 election cycle included: (1) two monetary contributions totaling \$1,100 to Frank Gordon, a candidate for Grays Harbor County Commissioner; (2) a \$1,000 monetary contribution to Jamie Nichols, a candidate for Grays Harbor County Commissioner; (3) a \$500 monetary contribution to Teresa Pursell, a candidate for State Representative; (4) a \$500 monetary contribution made to Mike Chapman, a candidate for State Representative; and (5) a \$900 monetary contribution to the Thurston County Democrats. The C-4 reports disclosing the \$4,000 in contributions made were filed by the Committee between 23 and 206 days late.

During 2016 the Committee failed to file C-3 and C-4 reports electronically using the Online Reporting of Campaign Activity (ORCA) software, or similar campaign finance reporting software.

Calendar year 2017: On September 10, 16, and 17, 2019, the Committee electronically filed C-3 and C-4 reports for April 1 through December 31, 2017, and electronically filed C-3 and C-4 reports covering January 1 through March 31, 2017, for C-3 and C-4 reports that had been filed manually on paper. The C-3 and C-4 reports filed by the Committee disclosed \$17,605 in contributions had been received and \$13,751 in expenditures made for calendar year 2017, with the majority of the Committee's activities involved running the party and various party building and fundraising activities. The fundraising activities included the proceeds from running the Burger Booth at various events including at the Grays Harbor County Fairgrounds, the Logger's Playday, and there were also rental and storage fees. No monetary or in-kind contributions were made to any candidates or political committees during calendar year 2017. The C-3 and C-4 reports were filed between 616 and 981 days late.

During 2017 the Committee failed to file C-3 and C-4 reports electronically using the ORCA software, or similar campaign finance reporting software.

Election Year 2018: On September 17, 2019 the Committee electronically filed C-3 and C-4 reports for March 1 through December 31, 2018, and electronically filed C-3 and C-4 reports covering January 1 through February 28, 2018, for C-3 and C-4 reports that had been filed manually on paper. The C-3 and C-4 reports filed by the Committee disclosed \$19,603 in contributions received and \$14,051 in expenditures made that included party building activities such as fundraising proceeds and costs from running the Burger Booth at the Grays Harbor County Fair, Logger's Playday, and various other events fees, and making a few small contributions to candidates.


The Committee reported contributions to local candidates Kym Foster (\$250) and Chris Thomas (\$250). Its contributions came from small donations and proceeds from the fundraisers. The late reports were filed between 250 and 584 days late.

The Committee would like to avoid the time and expense resulting from a Brief Adjudicative Proceeding (Brief Enforcement Hearing) being scheduled by Public Disclosure Commission (PDC) staff.

Therefore, in lieu of PDC staff scheduling a Brief Enforcement Hearing, I am completing this Statement of Understanding, and enclosing a check or money order in the amount of \$900 as a penalty payment in this matter. The \$900 penalty being assessed in this matter is in accordance with the Penalty Schedule adopted by the Commission for Brief Enforcement Hearings set forth in WAC 390-37-143 as follows:

- \$300 for the two acknowledged violations of RCW 42.17A.245 by failing to electronically file C-3 and C-4 reports in 2016 and 2017 (\$150 for each year);
- \$300 for the acknowledged violations of 42.17A.235 and .240 listed above for failing to timely and accurately file C-3 and C-4 reports during 2016, including disclosure of \$4,000 in contributions made to candidates and a political party committee; and
- \$300 for the acknowledged violations of 42.17A.235 and .240 listed above for failing to timely and accurately file C-3 and C-4 reports for calendar years 2017 and 2018, (\$150 for each year)

I understand that by completing this Statement of Understanding, I am acknowledging multiple violations of RCW 42.17A set forth above and are waiving the right to a hearing in this matter.
