<b>Complaint Description</b>
<p><a href="#">Glen Morgan</a> reported via the portal  <i>(Mon, 21 Aug 2023 at 10:34 PM)</i>  To whom it may concern,</p> <p>It has come to my attention, that the Retired Public Employees Council of Washington PAC has violated Washington State's campaign finance laws (<b>RCW 42.17A</b>). The specific violations are detailed below:</p> <p><b>1) Attempting to conceal the truth about political activity from the public by waiting weeks, months, or even years to report what they did or who funded them (Violation RCW 42.17A.235, RCW 42.17A.240)</b></p> <p>As I was surfing PAC PDC filings in between Netflix binge-watching, I found this one. I don't really know anything about them, other than the fact that they seem to like breaking the law. They aren't alone in this activity, of course, but I try to do my civic best to inform the PDC about what I find, and this one deserves to get tossed in the hopper along with the rest of the prolific lawbreakers out there.</p> <p>I try to provide specific examples of lawbreaking in a very easy-to-read and simpler to understand spreadsheet format. This is both for PDC staff convenience, but it also helps the lawbreakers use the list as a reference sheet so that they can go back and try to explain, justify, or excuse their repetitive lawbreaking activities. I've attached this both as an Excel file and a PDF so that everyone involved can get the optimal value from the effort. Please note that the original report referenced in the spreadsheet can be linked by clicking on the far-right column. I believe this makes it easier for everyone.</p> <p>A quick note again on how this report is organized. I've <b>organized it by latest report first</b>. You'll note that the latest report filed by this group was 481 days late (two reports were that late), which isn't this year's state record for me in the lawbreaking I've uncovered, but it deserves honorable mention. Only a rare handful of other dark money PACs have concealed the truth this long.</p> <p><b>I've color coded the most extreme late reports red, as I usually do, of which there are 80 of these.</b> This is substantial, even for someone as experienced as I am at uncovering the corrupt and lawbreakers. This was some impressive lawbreaking here. This alone was enough to justify filing a complaint against this gang. However, they also filed 16 distressingly late (color coded orange – it is bad and illegal, but not as bad as the extremely late reports referenced earlier), and another 20 sloppily late (color coded yellow). I admit the</p>

sloppily late reports by themselves wouldn't have inspired me to file this complaint, but when reviewing for a pattern of lawbreaking behavior, they merit inclusion, and I like to be inclusive.

Of course, as usual, when I find shady groups willing to so openly break the law I usually look deeper into their past filings to see what other laws they enjoy breaking too. I'm rarely disappointed, and these guys did not disappoint (well, to be fair, it is disappointing to see them be so willing to flout the law, but it is probably more accurate to say they didn't surprise me with their continued lawbreaking):

**2) Failure to accurately describe expense, and the illegal concealment of required information from the public. (Violation of RCW 42.17A.240, RCW 42.17A.235 & WAC 390-16-037)**

Once I realized this PAC would so egregiously violate the law with such reckless disregard for the public to know the truth, I kept looking closer. It turns out this PAC has failed to follow Washington State's Campaign Finance laws as they apply to the reporting of expenditures frequently (of course). Here **are a few specific examples of failing to follow the law. These are clear and explicit violation of WAC 390-16-037:**

- On **PDC Report # 110089877, attached for staff reference**, this PAC claims to have **spent \$4,300.45 on printing** with no clear vendor, but of course, they failed to report the legally required details for this printing. How many pieces of literature was printed? Again, on the same report they reported mailing costs, but again, they don't provide the legally required details – how many pieces did they mail? This is an **explicit violations of WAC 390-16-037, Example B.**
- On **PDC Report # 110129144 , attached for staff reference**, this PAC **claims to have spent \$1,052.80 on an endorsement mailing.** Once again, no details provided. How many pieces mailed? Again, another **clear and obvious violation of WAC 390-16-037, Example B.**
- 

It seems likely, in light of this PACs tendency to conceal so much for so many years from the public with their late reports, that these additional examples of lawbreaking are probably just scratching the surface and there are likely to be even more violations if PDC staff looks closer.

Based on the late reporting, I do strongly suggest that the PDC gets a subpoena for the bank records on this PAC and see how far off the bank account records are from the public reports filed by this entity. It seems like you could save a lot of time and hassle taking this approach.

Regardless, it is a shame these well-funded PACs can't follow the law.
