To whom it may concern,

It has come to my attention, as it has in the past, that the Snohomish County Democrats, as they are inclined to do, have violated Washington State's campaign finance laws (**RCW 42.17A**), the specific violations are detailed below:

1) Attempting to conceal the truth about political activity from the public by waiting weeks, months, or more to report what they did or who funded them (Violation RCW 42.17A.235, RCW 42.17A.240)

I realize this allegation doesn't surprise anyone who has paid any attention to this shady and prolific law breaking crew over the past few years. This crew was caught breaking this exact law in the past (PDC Enforcement Case #40870 and was formally sanctioned with a Warning Letter at the time – See attached Warning Letter and earlier than this based on a complaint I filed – see PDC Enforcement Case #25234 from 2017, original complaint I filed against this crew attached along with the "reminder" letter) Of course This group apparently enjoys breaking the law, so I thought I would revisit their activities once again, as I have been doing over the past week, and help the PDC address this troubled group and their wayward ways. Those who enjoy breaking the law like these guys never stop, so those of us who are inclined to pay attention can't really stop either.

First, let's just review the late reporting, which is essentially an effort by this secretive, repetitively lawbreaking PAC to conceal the truth from the public for as long as they believe they can. Even a casual review of this crew's history shows they do this all the time.

As usual, when I'm revisiting the frequent lawbreaker club, and the Snohomish County Democrats are one of the frequent violator lawbreakers, I try to provide the specific examples of lawbreaking in a very easy-to-read and simpler to understand spreadsheet format. This is both for PDC staff convenience, but it also helps the lawbreakers use the list as a reference sheet so that they can go back and try to explain, justify, or excuse their repetitive lawbreaking activities. I've attached this both as an Excel file and a PDF so that everyone involved can get the optimal value from the effort. Please note that the original report referenced in the spreadsheet can be linked by clicking on the far-right column. I believe this makes it easier for everyone.

It appears that the Reminder Letter and the Warning Letter they received from the PDC served more as an incentive to keep breaking the law rather than any type of cautionary restraint on their lawbreaking. That free pass has led to the violations detailed below.

A quick note again on how this report is organized. I've **organized it by latest report first.** You'll note that the latest report filed by this group was 235 days late (two of them tied for this distinction) – which is pretty late.

I've color coded the most extreme late reports red, as usual, of which there are 125. I've color coded the problematically late orange, and there are only 24 of those 14-5 days late. Illegal, but not as egregious as most of their reports. Even just these reports alone would justify notice to the PDC, but they are overwhelmed by the more egregious volume of super late reporting color coded red in the attached spreadsheets. I've color coded the sloppily late reports yellow, and there are only 19 of those. So, it appears that when they want to break the law, they just go for months and conceal everything. The attached spreadsheet and PDF file of this information should be adequate to verify this allegation. I'm sure every one of these violations has a story behind it – and it would be good to get a complete picture of the stories and yarns they will spin this time.

By the way, this extensive and exhaustive list of violations clearly indicates that it is highly likely the reports being filed right now by this group are inaccurate, and it would not a bad idea for PDC staff to subpoena the bank records and see how far off the C4 reports have been when filed on behalf of this crew.

2. Failure to list the vendor and the address of the vendor for in-kind contributions, therefore concealing from the public the true source of these contributions (Violation of RCW 42.17A.240, RCW 42.17A.235)

When an individual or entity makes a donation of goods or services to a political committee so that the committee may attempt to sell these goods or services to others in exchange for money, this is an in-kind contribution.

I want to draw attention to the PDC's own website recommendations for how PACs and campaigns need to report this information.

Specifically, I want to draw attention to the PDC's specific requirements of reporting:

"In-kind donations that are not incidental **must** be fully reported in Part 1 of Schedule B to the C-4 **with the following details:** the date the contribution was received; the name and full address of the contributor; **if the in-kind contribution is a good or service purchased from a vendor,** 

include the name and address of the vendor; a brief description of the contribution; its fair market value; the cumulative total this contributor has given for the primary or general election, whichever applies; a designation whether this contribution is for the primary or general election; and if the contributor is an individual who has cumulatively given more than \$250 to the campaign, including both primary and general contributions, identify the individual's employer (by name, city and state) and occupation."

This committee has failed to do this for both auction items and regular in-kind contributions.

For both staff and the lawbreaker's reference, I will detail just a few of the many deficient examples provided, so that the obvious lawbreaking can be more efficiently spotted and hopefully corrected in the future to prevent the need to file complaints like this one:

• Violation Example #1-#14 - Multiple In-Kind Contributions were made – to the Snohomish County Democrats, for everything from "toilet tissue" to "wine tasting" (PDC Report # 110002063, attached for staff reference), the address for the vendor where generous in-kind contributors purchased the goods is not provided, despite the crystal-clear legal requirement to do so. Another odd thing is the perfectly rounded numbers for the second "in-kind contribution" here would indicate a lack of receipts and accuracy. This is a real problem for this PAC, and they should go back and correct this report and others where they may have committed the same violation.

This PAC can easily go back and correct these reports to get back to at least a pretense of compliance. This should be an easy fix to this aspect of their lawbreaking, and they should promise, once again, to stop breaking the law moving forward. The bigger concern, of course, is the excessive and egregious efforts to conceal the truth from the public as indicated in the first allegation above.

Let me know if you need more violations to be uncovered by this PAC. I only made a quick, cursory review, so I am sure I missed other violations.

As noted in the letter to Kelly Wright, the PDC has dismissed this matter in accordance with RCW 42.17A.755(1) and will not be conducting a more formal investigation into these allegations or taking further enforcement action in this matter.

However, pursuant to WAC 390-37-060(1)(b), the Snohomish County Democratic Central Committee is hereby formally warned concerning the failure to timely and accurately file Monetary Contribution reports (C-3) and Summary Full Campaign Contributions and Expenditure reports (C-4 reports) in accordance with RCW 42.17A.235 and .240.

This formal written warning comes with the staff's expectation that the Committee will file timely, complete and accurate campaign finance reports in future years as required for a bona fide political party committee under the Full Reporting Option. The Commission will consider this formal written warning in deciding on further Commission action if there are future violations of PDC laws or rules.

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on October 26, 2018, against the Snohomish County Democratic Central Committee (Committee), a bona fide county political party organization registered with the PDC as a committee since at least 1996. Specifically, you alleged that the Committee may have violated RCW 42.17A.235 and .240 by failing to timely file complete and accurate Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contributions and Expenditure reports (C-4 reports) disclosing: (1) the receipt of a \$900 contribution from the 44<sup>th</sup> Legislative District Democrats; (2) a \$3,000 expenditure for a monetary contribution made to Jared Mead; and (3) the reporting of the Blue Wave Gala event held on September 29, 2018.

PDC staff reviewed the allegations listed in the complaint you filed, the statutes, rules and reporting requirements, the C-3 and C-4 reports filed by the Committee, and the response to the complaint provided by Richard Moralez, former Committee treasurer and Eric Halvorson, current Committee treasurer.

Based on staff's review, we found the following:

 The Committee filed an amended Committee Registration (C-1pc report) on Feb. 26, 2018, selecting the Full Reporting Option and listing Hillary Moralez as Campaign Manager and Richard Moralez as Treasurer.

- For the 2018 election cycle, the Committee was required to file monthly C-3 and C-4 reports for January 1 through June 30, 2018, if the committee has received more than \$200 in contributions or made expenditures of more than \$200 since the last C-4 report was filed. The C-3 and C-4 reports are required by the 10<sup>th</sup> of the month, disclosing contribution and expenditure activities undertaken in the prior period. Beginning June 1, 2018, the Committee was required to file weekly C-3 reports, and 21-Day, 7-Day and Post-Election C-4 reports for both the primary and general elections.
- On September 25, 2018, the Committee filed the following three C-4 reports late: (1) The 21-Day Pre-Primary Election C-4 report was required to have been filed by July 17, 2018, and disclosed \$2,582 in expenditures that included \$1,750 rental deposit for an annual event, rent, the post office box rental, and telephone; (2) The7-Day Pre-Primary Election C-4 report was required to have been filed by July 31, 2018, and disclosed \$733 in expenditures that included printing event card invites, insurance, and service fees to process online contributions received; and (3) The Post -Primary Election C-4 report was required to have been filed by September 12, 2018, and disclosed \$4,604 in expenditures that included a \$3,000 monetary contribution made to Jared Mead, a candidate for State Representative in the 44th Legislative District on August 4, 2018, and expenditures related to the upcoming event.
- The Committee disclosed the contribution to Jared Mead 15 days late. (Friends of Jared Mead reported the contribution timely).
- On September 25, 2018, the Committee filed a C-3 report totaling \$2,060 and disclosing five itemized contributions received between June 18 through 21, 2018, that included: (1) the \$900 contribution from the 44<sup>th</sup> Legislative District Democrat's listed in your complaint; (2) a \$800 contribution from Elizabeth Larson; and (3) a \$300 contribution from the 1<sup>st</sup> Legislative District Democrat's. The contributions were required to have been disclosed no later than July 2, 2018 and were disclosed 85 days late, and it appears the contributions were not timely deposited within five business days of receipt.
- The Committee responded on October 25, 2018, stating "We have since amended the offending C-3 reports concerning the Blue Wave Gala Fundraiser to more accurately reflect the event." Staff reviewed the information and found that the Committee filed an amended C-3 report (Report # 100868916) on October 25, 2018, disclosing \$2,335 in contributions received on September 29, 2018. The 16-page amended C-3 report

amended the previously filed five-page C-3 report (Report # 100862221) initially filed on October 1, 2018.

- For calendar year 2018, the Committee filed 238 C-3 reports that included 35 amended C-3 reports, and 25 C-4 reports that included 15 amended filings. The majority of the amended reports were filed between October 25 through November 10, 2018, after Eric Halvorson became Committee treasurer.
- Richard Moralez stated he had technical issues and lack of knowledge using the Online Reporting of Campaign Activities (ORCA), the electronic filing software provided by the PDC. Mr. Moralez stated his "full responsibility that my reporting fell behind. Please understand this was not intentional. I had a computer that kept crashing and having to input everything repeatedly. Use of a crashing computer system only added to the problem. I thank all the people that have been helping me to correct this matter and a new oversight finance committee will be selected to keep the Snohomish County Democratic Central Committee (SCDCC) in compliance going forward."
- Stephanie Vignal, Committee Secretary notified the PDC on October 16, 2018 that Richard Moralez had unexpectedly passed away that week, and his daughter, Hillary Moralez, is the Committee Chair. Ms. Vignal emailed the PDC stating the Committee "will do our best to provide timely reporting and make sure everything is updated properly."
- On Oct. 17, 2018, the SCDCC filed an amended C-1PC, changing its name to the Snohomish County Democratic Party (Party) and listing Hillary Moralez as Campaign Manager and Eric Halvorson as Treasurer.
- The Committee filed a 21-Day Pre-General Election C-4 report on October 20, 2018, four days late disclosing \$15,3415 in contributions received and \$1,570 in expenditures made. The Committee filed two amendments to this report on November 9 and 10, 2018 respectively.
- The Committee timely filed its 7-Day Pre-General Election C-4 report on October 30, 2018, disclosing \$185 in contributions received and \$39,790.99 in expenditures made.

The Committee filed two amendments to this report on November 9 and 10, 2018 respectively.

Based on these findings, and the extenuating circumstances of the death of the Committee treasurer, staff has determined that in this instance, the failure to timely file C-3 and C-4 reports disclosing contributions and expenditures does not amount to a material violation warranting further investigation.

Pursuant to WAC to WAC 390-37-060(1), the Snohomish County Democratic Central Committee will receive a formal written warning concerning the failure to comply with the reporting requirements and to timely and accurately file C-3 and C-4 reports disclosing contributions and expenditures activities in accordance with RCW 42.17A.235 and .240.

PDC staff has the expectation the Snohomish County Democratic Central Committee will timely file complete and accurate reports in future years in accordance with PDC laws and rules, including the timely depositing of contributions within five business days of receipt.

The Commission will consider the formal written warning in deciding on further Commission action if there are future violations of PDC laws or rules.

Based on this information, the PDC has dismissed this matter in accordance with RCW 42.17A.755(1).

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed Sept. 18, 2017, against the Snohomish County Democratic Central Committee (Committee), a bona fide county political party organization registered with the PDC as a committee since at least 1996. Specifically, you alleged that the Committee may have violated RCW 42.17A.235 and .240 by failing to timely file complete and accurate Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contributions and Expenditure reports (C-4 reports).

PDC staff reviewed the allegations listed in your complaint, the statutes, rules, and reporting requirements for a political committee, the Committee Registrations (C-1pc report), Monetary Contributions reports (C-3 reports), and Summary Full Campaign Contribution and Expenditure reports (C-4 reports) filed by the Committee, and the response provided by Eric Halvorson, current Committee treasurer, and data in the PDC contribution and expenditure database filed by the Committee.

Based on staff's review, we found the following:

- On February 17, 2017, the Committee filed a C-1pc report as a continuing committee selecting the Full Reporting Option and listing Mario Brown as Campaign Manager and Garrett G Havens as Treasurer.
- On February 26, 2018, the Committee filed an amended C-1pc report as a continuing committee, selecting the Full Reporting Option and listing Hillary Moralez as Campaign Manager and Richard Moralez as Treasurer.
- On October 16, 2018, Stephanie Vignal, Committee Secretary notified the PDC that Richard Moralez had unexpectedly passed away that week, and his daughter, Hillary Moralez, is the Committee Chair.
- On Oct. 17, 2018, the Committee timely filed an amended C-1pc report changing its name to the Snohomish County Democratic Party (Party) and listing Hillary Moralez as Campaign Manager and Eric Halvorson as Treasurer.

- Staff's review found that in 2017 the Committee received \$53,897 in total contributions and made \$47,024 in expenditure. The initial C-4 reports were timely filed by the Committee, including the 21-Day, 7-Day and Post Primary and General Election C-4 reports disclosing: (1) two expenditures totaling \$18,414 to Tulalip Resort Casino for a fundraising dinner for the committee; (2) \$3,500 to Turner World Enterprises, LLC for a speaker's fee; (3) \$3,100 to the Everett Building Trades Association for rent for 2017; and (4) a \$3,075 expenditure for fair booth rental at the Evergreen State Fairgrounds.
- The review found the Committee made a total of \$4,000 in monetary contributions in 2017 that included a \$3,000 contribution to Brian Sullivan for Everett Mayor on June 18, 2017, and \$1,000 to the Snohomish County Young Democrats made on September 15, 2017. The review also found that the Committee filed C-3 reports on the C-4 reports dates for all of calendar year 2017, instead of filing weekly C-3 reports for contributions received and deposited beginning June 1, 2017.
- Mr. Halvorson stated in his response "As is unfortunately very normal in all-volunteer organizations like ours, the persons responsible for maintaining records and filing accurate reports with the PDC are no longer in office. The Snohomish County Democratic Central Committee has since elected a new chair and a new treasurer, and it is our commitment moving forward that all of our finances and the necessary reporting of same should be able to withstand the toughest scrutiny with flying colors."
- On Dec. 4, 2018, PDC staff issued a formal written warning to the Committee for PDC Case
  40870 concerning the allegations of failing to timely and accurately file C-3 and C-4 reports
  disclosing contributions and expenditures activities in accordance with RCW 42.17A.235 and
  .240. In the letter, PDC staff stated the expectation the Committee will timely file complete
  and accurate reports in future years in accordance with PDC laws and rules, including the
  timely depositing of contributions within five business days of receipt.

PDC staff found no evidence of a material violation that would require conducting a more formal investigation into your complaints or pursuing enforcement action in this instance. However, based on the mitigating factors listed above, PDC staff is reminding the Snohomish County Democratic Party about the importance of timely and accurately filing C-3 and C-4 reports disclosing contribution and expenditure activities, especially the requirement to file weekly C-3 reports beginning June 1 when the committee is participating in any election in the future.
