<p><a href="#">Glen Morgan</a> reported via the portal (Sat, 26 Aug 2023 at 11:25 PM)</p> <p>To whom it may concern,</p> <p>It has come to my attention that the IAFF Local 2781 PAC has been violating Washington State’s campaign finance laws for years. The details are as follows:</p> <p><b>1) Attempting to conceal the truth about political activity from the public by waiting weeks, months, or more to report what they did or who funded them (Violation RCW 42.17A.235, RCW 42.17A.240)</b></p> <p>Even a casual review of this shady PAC’s PDC filings reveals something is seriously wrong here. It is particularly concerning since many of these reports were actually filed months and even years late finally revealing the reported *truth* about this PAC that was concealed from the public during various campaigns – most reports were filed long after the election was over. Of course, there is no way to know if anything this PAC has reported is even close to truthful today.</p> <p>As usual, I try to provide the specific examples of lawbreaking in a very easy-to-read and simpler to understand spreadsheet format. This is both for PDC staff convenience, but it also helps the lawbreakers like this crew use the list as a reference sheet so that they can go back and try to explain, justify, or excuse their repetitive lawbreaking activities. I’ve attached this both as an Excel file and a PDF so that everyone involved can get the optimal value from the effort. Please note that the original report referenced in the spreadsheet can be linked by clicking on the far-right column. I believe this makes it easier for everyone.</p> <p>A quick note again on how this report is organized. I’ve <b>organized it by latest report first</b>. You’ll note that the latest report filed by this guy was 1500 days late which is many years late, and very close to the monthly record of the worst violator I’ve caught this month. <b>There is always something wrong when a PAC is filing many reports many years later.</b></p> <p><b>I’ve color coded the most extreme late reports red, as usual, of which there are 39.</b> I’ve color coded the problematically late orange, but there are only 4 of those 15-12 days late. Illegal for sure, but the majority of the reports this PAC filed were over 1,168 days late– strategically organized to conceal the truth from the public when a political campaign is in process and then waiting years to come clean. This is a very serious and concerning pattern of behavior.</p> <p>It appears that when this PAC wants to break the law (which seems the default status), they just go for years and conceal everything from the public. The attached spreadsheet and PDF file of this information should be adequate to verify this allegation. I’m sure every one of these violations has a story behind it – and it would be good to get a complete picture of the stories and yarns she will spin to explain this pattern of troubling illegal behavior.</p> <p>By the way, this extensive and exhaustive list of violations clearly indicates that it is highly likely the reports recently filed and not yet refiled are inaccurate, and it would not a bad idea for PDC staff to subpoena the bank records and see how far off the C4 reports have been when filed on behalf of this PAC.</p>



## **2) Apparent theft of PAC funds, misuse of PAC funds, disappearing PAC funds for likely personal or unknown use (Violation of RCW 42.17A.445)**

This is one of those violations that should not happen in any real campaign run with even amateur treasurers and unserious candidates. Money should not be disappearing, vanishing, or getting secretly pocketed or extracted from the PAC with no explanation. Everyone should take these types of violations seriously. Yet, that is exactly what appears to have happened here, based upon the admittedly, illegally late and very deficient reporting made by this PAC.

First, it appears that **approximately \$511.50 has vanished**. The last C4 (expenditure report) this PAC filed for their 2019 existence reported they had \$8,316.75 cash on hand (see line 18) (See **PDC Report #110166417, attached for staff reference**). The first C4 (expenditure report) this campaign filed in 2020 (See **PDC Report #110166937, attached for staff reference**) claims that they started with \$7,802.25 on hand. **However, what happened to the missing \$511.50? We can only speculate because this PAC hasn't told us. Did they spend the missing funds at the local pot shop? Did they take a trip to Mexico? Did they squander it on lottery tickets? Who knows, but the public needs to know, and this issue should be resolved.**

Weirder than the missing funds, and even more troubling, is the fact **that this PAC has not updated their C4 reports for the 2021, 2022, or the 2023 years of activity**, although they did file the missing/updated reports from 2019 in 2023 - many years late. How can the public possibly know what this crew is doing with their campaign cash?

## **3) Total failure to report contributions of any kind in 2022, despite reports from candidate that they received cash contributions that same year (Violation of RCW 42.17A.235, RCW 42.17A.240)**

I have been able to identify at least one contribution made by this secretive PAC to a candidate for Snohomish County Prosecutor Jason Cummings in 2022 for \$1,000 (See **PDC Report # 110105589, attached for staff reference**). This PAC is still concealing this information from the public years later. Obviously, there are probably many other contributions this PAC has made and other activity that is still being concealed from the public right now.

## **4) Failure to provide addresses for the candidates to whom this PAC funneled cash (Violation of RCW 42.17A.240(7))**

Again, this is just typical when a PAC has no intention to follow the law. See **PDC Report # 110166407, attached for staff reference**. They seem to identify giving cash to some politicians, but bizarrely they don't provide the addresses for most of them, which is **a clear violation of RCW 42.17A.240(7)**.

## **Why it is so important that PACs like this one be held accountable for illegally late reporting and other violations.**

PDC staff will note that this PAC claims to have given two different contributions to Evan Merritt, a candidate for Fire Commissioner in 2019 (see **C1 filed with PDC, attached for staff reference**). As staff (and the public) will notice, this politician filed as a mini-reporting campaign, which meant at the time of his campaign he could accept no more than \$500 from any one contributor. However, as the C4 I attached and referenced above (**PDC Report #110166407**) so clearly reports – this PAC gave two contributions one for \$500 and the other for \$1,000 to this same Fire Commissioner candidate. This was clearly a violation of the mini-reporting rules and exceeded the mini-reporting limits by at least \$1,000. There is no evidence of a reimbursement to this PAC from this candidate, so it appears that candidate also violated campaign finance laws by accepting overlimit contributions to his mini-reporting campaign.



Obviously, I'll file a separate complaint against the Fire Commissioner, but this report was filed so many years late, it was impossible to even discover this truth until recently. Again, another strong reason to sanction this PAC and their open flouting of Washington State's campaign finance laws. If the campaign finance laws are to have any relevance, they need to be enforced with monetary penalties and sanctions, which this PAC has clearly earned by its egregious and illegal behavior in this case.

Another related note for PDC staff reference. In the same report – years late – this PAC claims they gave \$950 to a candidate named Sam Wirsching, who was a 2019 candidate for Fire Commissioner. However, this super-secret candidate never filed a Financial Affairs Statement (F1), or a C1, or any other reports to the PDC during his failed 2019 political campaign. Discovering this discrepancy will also lead to a complaint I will file against this failed candidate as well, but I used this mainly as an example of how this secretive PACs illegal activities have concealed much from the public for years, and now that it is getting some sunshine on the truth, there is a lot of bad stuff that should have been revealed to the public years ago.

Feel free to let me know if you need anything else on this PAC, but it seems like such a mess I can't even imagine PDC staff can resolve this case without subpoenas of the bank records just to get some forensic accounting work done. Obviously, nothing has been reported accurately from this crew.

When a secretive dark money PAC like this one conceals the truth from the public for years, apparently loses (or has stolen, or misuses and vanishes) campaign cash, and when they clearly violate mini-reporting rules by contributing far in excess of mini-reporting contribution limits (and concealing this fact for years), there is something wrong here. Very wrong. The public has a right to know, and this PAC is hiding everything from the public.
