To whom it may concern,

It accidentally came to my attention that Sam Wirsching, candidate for Snohomish Fire Commissioner violated Washington State's campaign finance laws (RCW 42.17A) during his failed 2019 campaign. The details are as follows:

1) Failure to file a candidate registration form after becoming a candidate (Violation of RCW 42.17A.205)

This failed politician came to my attention because of my investigation into IAFF Local 2781 PAC and their late reports. I noticed contributions to this candidate and that is when I found out they hadn't even filed a C1 report.

2) Failure to file a Financial Disclosure report (Violation of RCW 42.17A.700, RCW 42.17A.210, RCW 42.17A.215)

I also noticed that this candidate did not file a Financial Affairs Statement (F1) with the PDC at the time, and they therefore concealed information about their depositories for campaign funds as well as the identity of their treasurer.

3) Failure to file any campaign contribution or expenditure reports (Violation of RCW 42.17A.235, RCW 42.17A.240)

Again, the reason why I even noticed this candidate was because of a \$950 contribution made to him by the IAFF Local 2781 PAC (See PDC C4 Tracking #110166407, attached for staff reference. Clearly, if this candidate was accepting contributions over the \$500 limit for mini-reporting – then they wouldn't qualify for that option regardless, and they should be full reporting. There is no evidence this money was returned to the PAC. What was it spent on? Who else funded this candidate? Many questions are left unanswered because the public has been denied all the information.

The violations here are clear, obvious, and self-evident. Let me know if you need anything else.
