## **Complaint Description**

To whom it may concern,

It has come to my attention, that the Washington Political Action For Candidate Election (PACE- NASW WA) PAC has a very awkward name, but also violated Washington State's campaign finance laws (**RCW 42.17A**). The specific violations are detailed below:

1) Attempting to conceal the truth about political activity from the public by waiting weeks, months, or even years to report what they did or who funded them (Violation RCW 42.17A.235, RCW 42.17A.240)

While the name of this shadowy PAC is awkward, there is no law against that. However, the fact they spend most of their time breaking the law is the bigger concern here for me and the rest of the public.

As PDC staff are well aware, I've caught many weird, secret, shadowy dark money PACs like this one breaking the law, and some have been fined or sanctioned for their lawbreaking. However, I believe this is my first complaint against this particular mob. I don't know why I didn't file a complaint on them earlier – they were practically begging for one. But, my recent attention lapse and laziness is something I hope to rectify now.

I try to provide specific examples of lawbreaking in a very easy-to-read and simpler to understand spreadsheet format. This is both for PDC staff convenience, but it also helps the lawbreakers like this crew use the list as a reference sheet so that they can go back and try to explain, justify, or excuse their repetitive lawbreaking activities. I've attached this both as an Excel file and a PDF so that everyone involved can get the optimal value from the effort. Please note that the original report referenced in the spreadsheet can be linked by clicking on the far-right column. I believe this makes it easier for everyone.

A quick note again on how this report is organized. I've **organized it by latest report first.** You'll note that the latest report filed by this group was 739 days late, which takes a lot of effort to break the law for that long – almost two years.

I've color coded the most extreme late reports red, as I usually do, of which there are 40 of these. This is impressive lawbreaking considering they seem to pretty much conceal most of their political information long past the year in which they were politically active. This is some impressive lawbreaking here. This alone was enough to justify filing a complaint against this gang. However, as has been my recent practice over the past month, I've also color coded the reports that were troublingly late (14-12 days). There were only 4 of these. Plus, I color coded the sloppily late reports (5-1 days), but there were only two of them. Most of the reports this crew had – they just went all the way and kept the information secret from the public for months or years.

There isn't much else to say about this crew. They don't follow the law, they haven't followed the law, and they appear unlikely to follow the law in the future, and, in fact, based on this past behavior – it is almost certain their current filings are not accurate either.
