Hello Tabatha,

Thank you for sending this information to us, apologies for the delay. The King county young democrats earlier this year, made a decision to remove our account from the PDC, we just forgot to follow up on that. I hope you can see from the attached documents that there has been no malfeasance in our bookkeeping. Additionally, our former treasurer wanted us to share the three points below:

1. 2020 \$250 contribution to KCDCC -- KCYD mini filed for the year and was not required to file any additional reports per PDC website.

2. 2021 Filing -- See C3s and C4s. Going into 2021 KCYD had ~\$6300 on hand and raised ~\$1050 from small contributions from members' dues. The money was not previously reported as KCYD mini filed for previous years and did not have an obligation to file additional reports. While the reports were filed late, IIRC PDC verbally told me that this was fine and thanked me for reaching out to file for 2021.
3. KCYD misfiled/filed late to conceal the truth -- KCYD accidentally chose to full file for 2021 and this was later amended in 2022 by me. There are no prior filings because KCYD mini filed.

We are sorry for the miscommunication, if you need any further documents from us please feel free to reach out and we will provide them. In addition to that, once that complaint is resolved, can you inform us of the best person to speak to about removing ourselves from the PDC? We don't spend money on candidate support and want to avoid an issue like this in the future.
