#### **Complaint Description**

**Glen Morgan** reported via the portal

(Wed, 30 Aug 2023 at 9:33 AM)

To whom it may concern,

Not surprisingly, it has come to my attention that the Clallam County Democrats have been violating Washington State's campaign finance laws (**RCW 42.17**A) for many years now. The details are as follows:

1) Attempting to conceal the truth about political activity from the public by waiting weeks, months or even years to report what they did with their cash pile used to influence elections (Violation RCW 42.17A.235, RCW 42.17A.240)

As I have reviewed the "frequent flier" list of organizations that seem habitually addicted to lawbreaking, this group seems to always be on the list. As I have mentioned before, I can only approximate this feeling to one of checking in on an old friend who was a longtime drug addict, but recently got clean out of rehab. You may not be surprised he relapsed, but it still makes you sad. Unfortunately, it just appears like the Clallam County Democratic Central Committee are addicted to lawbreaking, and nothing short of frequent fines, judgments and sanctions are likely to cure them from this habit.

As has been my habit, I try to provide the specific examples of lawbreaking in a very easy-to-read and simpler to understand spreadsheet format. This is both for PDC staff convenience, but it also helps the lawbreakers like this crew use the list as a reference sheet so that they can go back and try to explain, justify, or excuse their repetitive lawbreaking activities. I've attached this both as an Excel file and a PDF so that everyone involved can get the optimal value from the effort. Please note that the original report referenced in the spreadsheet can be linked by clicking on the far-right column. I believe this makes it easier for everyone to verify the accuracy of the complaint and audit the nature of the information concealed from the public.

A quick note again on how this report is organized. I've **organized it by latest report first.** You'll note that the latest report filed by this group was 140 days late which is several months late, and many of these late reports were unfortunately made AFTER the election was long over and therefore concealed all the information from the public during the critical 21 days before an election.

I've color coded the most extreme late reports red, as usual, of which there are 40 with this crew. Please note the majority of these involve large transactions. I've color coded the problematically late orange, and there are 10 of those 14-6 days late. Illegal for sure, but obviously the majority of the reports this PAC filed were extremely late. These problematically late reports are worth reporting to the PDC as serious violations on their own, but when combined with the extreme late reports, it is more than a pattern of behavior – it is an addiction to lawbreaking that is clearly hard to kick with this crew. I also color coded the sloppily late reports yellow, and there were 27 of those – by itself I wouldn't file a complaint on just sloppy filing, even when it is habitual and repetitive like with these guys. However, the sheer volume of this problem clearly indicates a pattern of behavior and a lack of concern about transparency and honesty in the political process. The biggest problem here, of course, are the seriously late reports. This is a very serious and concerning pattern of behavior.

Unfortunately, as I have discovered in the past, if a group like this is willing to violate the most fundamental principle of campaign finance law – revealing the truth about their attempts to influence the outcome of an election in a timely way – then they are likely to violate other aspects of the law. This appears to be true in this case because, unfortunately it only gets worse from here:

# 2) Apparent theft of campaign funds, misuse of campaign funds, disappearing campaign funds for likely personal use. Also unaccounted mystery funds "appearing" in reported bank account (Violation of RCW 42.17A.445)

This group manages two different PACs. They differentiate the two entities by calling one "Limited" and the other "unlimited." I'm presuming they mean "Exempt" and "non-exempt" entities, but for the purposes of this complaint it doesn't really matter. Their math doesn't add up regardless of what they call it.

In the "Unlimited" entity, somehow this campaign, without explanation or clarity "disappeared" \$1,417.17 between the C4 (expense reports) reporting period of December 31, 2021, and January 1, 2022. The last C4 report in 2021 claims that the campaign had \$8,804.64 in the account after expenses (See PDC C4 Report # 110067734, attached for staff reference). However, when the next C4 expense report was filed picking up from when this last one supposedly left off – this secretive PAC claims that there were \$7,387.47 dollars in the bank (See PDC C4 Report # 110071828, also attached for staff reference). Where did the missing \$1,417.17 go?

Was it stolen by the campaign committee for themselves? Did the treasurer steal it? **Did they give secret** unreported contributions under the table to politicians? Was it misused illegally to fund someone's addiction to meth? Was it gambled away on with an unlucky bet on red at the Elwha River Casino? What happened here?

It wasn't just this "Unlimited" committee where the math doesn't make sense. A quick basic cursory review of the "Limited" PAC run by this gang also shows some math problems that need to be explained:

For example, In the "Limited" PAC's C4 (expense report) filings between December 31, 2021 and January 1, 2022, a mysterious \$38.91 "appeared" in the reported bank account balance without explanation or justification. Specifically, the last C4 filed for this PAC showed a final balance of \$18,997.77 (See PDC Report # 110067930, attached for staff reference). However the starting balance on this same PAC the next day showed a balance of \$19,036.68 (See PDC Report # 110071829, attached for staff reference). How did the sudden \$38.91 appear in the account? How did it get there? Where did it come from? Is it even accurate, or is this just someone trying to fake bank account balances that don't make sense? Unaccountable funds may not seem like a big deal, but it becomes particularly problematic when the C4 reports (line 18, in particular) don't line up with actual bank account balances for that month, as PDC guidance so clearly requires. Randomly changing amounts with mystery, unaccounted for cash appearing in the reports is just as much a problem as possible theft of funds from these PAC slush funds as well.

Unfortunately, this problem for the Clallam County Democrats just keeps getting worse the closer you look at how this crew operates or mismanages their funds. In the same "Limited" PAC's C4 (expense report) filing between December 31, 2022 and January 1, 2023, another \$1,403.18 "disappeared" without explanation or report. One day it was there, and the next day it vanished. I understand how this happens at the local casino or in county government, but when you are filing public reports with the PDC, you still have to explain how these funds vanish. For clarity and proof, this gang (as math challenged as they might be) claims they had \$22,849.94 in the bank December 31, 2022 (See PDC Report # 110131399, attached for staff reference). However, according to this same group when they filed their next C4 report, starting on January 1, 2023 (See PDC Report # 110134228, attached for staff reference), they only had \$21,446.76 in the bank account. What happened to the missing \$1,403.18? I understand the Elwah Casino can be tempting, but is that really where it went? Who stole it? Did they use it to buy meth to pay back drug addict voters who

**surrendered their signed ballots in Sequim? Someone knows, but they obviously aren't talking.** There are some real problems here.

## 3) Failure to properly identify as a sponsored committee (Violation of RCW 42.17A.005(47)(b)(i), WAC 390-16-011A)

The Clallam County Democratic Central Committee Unlimited (2023) PAC has received 100% of its funding from only one source, and this is the \$1,000 contribution from the People for Derek Kilmer federal PAC on May 5, 2023 (See C3 PDC Report #110145281, attached for staff reference). No other contributions were made. They were involved in the primary elections earlier this year, and they should have changed their name to "Clallam County Democratic Central Committee Unlimited PAC, sponored by People for Derek Kilmer PAC" in order to follow to the law.

The law is very clear, as **WAC 390-16-011A** clearly states:

"A sponsored political committee must amend its C-1pc sixty days before an election in which it participates if the committee's name on its most recently filed C-1pc does not include at least one current sponsor."

This political committee failed to comply with the law and correct it's C1PC documents to properly reflect that it was a wholly sponsored PAC with most of its funding coming from one guy (or at least one politician willing to use other people's money to fund this crew). This was a flagrant effort to conceal the truth, and it should be corrected now.

I will concede the possibility that this PAC is simply concealing the truth from the public as has been their habit for years (see allegation #1 above), but based on their reporting, and if they want to pretend to follow the law for now – they clearly need to correct their name to reflect their sponsorship status as a PAC sponsored by another PAC. It is perfectly understandable if they are embarrassed to be associated with Kilmer, but that is for them to resolve with themselves. They took his cash, and nobody else would support them, so they need to own it, if they have any interest in conforming to the law.

#### The Clallam County Democrats - A consistent history of lawbreaking

As I mentioned at the beginning of this complaint, the Clallam County Democrats have violated these same laws before. I've filed complaints on this same group for the same violations of the same laws in the recent past (See PDC Enforcement Case #25576, original complaint attached for staff reference). At that time, the PDC was struggling to adequately enforce the statute on lawbreaking groups like this, and in an effort to assist Bob Ferguson's AG staff, I took it upon myself to file a Citizen Action Notice lawsuit against this group and help the state collect a modest fine for the state treasurer (see original lawsuit attached – State of Washington, ex rel Glen Morgan vs. Clallam County Democrats – Thurston County Superior Court Case #17-2-06762-34 attached for staff reference). In the end, I felt sorry for this bumbling corrupt organization, and this case was settled for a modest settlement of \$12,100 including court costs and attorney fees (See attached settlement, for staff reference).

That case was settled on April 18, 2018, yet this group just seems addicted to lawbreaking, and it is clear that they will need consistent and regular investigations, fines, sanctions, and judgements in order for them to be convinced to follow the law. It is always challenging when you are dealing with people addicted to lawbreaking, but compliance is possible with enough attention.

It is clear that PDC investigative efforts should take nothing at face value from this organization and it is clearly important to file subpoenas for monthly bank records with this group and see if the respective monthly C4 reports (line 18) actually match the bank balances for this group. Based on the late reports and the past history, I am afraid I have probably only scratched the surface on the continued lawbreaking of this group.

It might be helpful to find out who stole the missing money from this group, if indeed it is stolen.

I'm not sure what it will take to convince these guys to follow the law, but as hard as the road to recovery might be for those addicted to drugs, I imagine it is a similar difficult road for groups like this who appear to be addicted to breaking the law. The first step on their journey towards redemption might very well be the next sanctions action by the PDC to help convince this group that following the law should matter to them.

Feel free to let me know if you want me to dig deeper with this crew, this is just an initial pass, and I'm sadly certain there is more bad behavior to uncover here.

The public has a right to know what shady political operations like these PACs are actually doing to influence elections in their community. The public should expect even frequent lawbreakers like this to be held accountable for their deceptive tactics.

The parties to this stipulation, Plaintiff, STATE OF WASHINGTON ex rel. GLEN MORGAN, and the Defendant, CLALLAM COUNTY DEMOCRATIC CENTRAL COMMITTEE, a political committee, being desirous of resolving all claims arising out of the Plaintiff's complaint, hereby enter into the following stipulation:

- Defendants agree to pay to the State of Washington an assessed civil penalty in the amount of \$6737.50 for their violations of RCW 42.17A as described in the complaint.
- The parties agree that \$5390.00 of the assessed civil penalty will be suspended based on the following terms and conditions:
  - a. The suspension will be in effect for four years from the date of execution of the Judgment. During the suspension, Defendants agree that they will not violate any provision of RCW 42.17A.
  - In the event the Defendant is found by the Public Disclosure Commission or a court to have committed a violation of RCW 42.17A during the suspension period, the

suspended penalty of \$5390.00 will immediately become payable within 30 days of such finding without further intervention of the Court.

- c. If Defendant is not found to have committed violations of RCW 42.17 by the Public Disclosure Commission or a court for conduct during the suspension period, then the suspended portion of the penalty shall be set aside.
- Defendants agree to pay the State the unsuspended portion of the civil penalty (\$1347.50)
   within 30 days of the date of entry of the Judgment.
- Defendants agree to pay, in a separate transmittal, the total amount of \$5362.50 as
  attorney fees, court costs, and costs of investigation to Kover Law, PLLC on behalf of the
  Plaintiff, this amount to be paid within 30 days of the date of entry of the Judgment.

THIS MATTER came on regularly before the undersigned judge of the aboveentitled Court. The Plaintiff, STATE OF WASHINGTON ex rel. GLEN MORGAN, appearing through its attorney of record, JUSTIN KOVER, and Defendant, CLALLAM COUNTY DEMOCRATIC CENTRAL COMMITTEE, appearing through their attorney, CRAIG RITCHIE, apprised the Court of their agreement to the entry of this judgment for the purpose of settling and compromising this action brought under RCW 42.17A. - RCW 42.17A declares as a matter of public policy "[t]hat political campaign and 1.3 lobbying contributions and expenditures be fully disclosed to the public and that secrecy is to be avoided." RCW 42.17A.001. Further, the statute provides that the provisions of the law "shall be liberally construed to promote complete disclosure of all information respecting the financing of political campaigns..." "A person who violates any of the provisions of [Chapter 42.17A] may be 1.4 subject to a civil penalty of not more than ten thousand dollars for each violation." RCW 42.17A.750(1)(c). "[A] person or entity who violates RCW 42.17A.405 may be subject to a civil 1.5 penalty of ten thousand dollars or three times the amount of the contribution illegally made or accepted, whichever is greater." RCW 42.17A.750(1)(c). "A person who fails to file a properly completed statement or report within the 1.6 time required by this chapter may be subject to a civil penalty of ten dollars per day for each day each delinquency continues." RCW 42.17A.750(1)(d). "A person who fails to report a contribution or expenditure as required by this 1.7
  - chapter may be subject to a civil penalty equivalent to the amount not reported as required." RCW 42.17A.750(1)(f).
- A civil action brought under RCW 42.17A.765 provides for "any appropriate 1.8 civil remedy, including but not limited to the special remedies provided in RCW 42.17A.750." RCW 42.17A.765.

## II. JURISDICTION, VENUE, AND STANDING

- 2.1 The Thurston County Superior Court has subject matter jurisdiction under the Campaign Disclosure and Distribution Act, RCW 42.17A.765(4), which authorizes a person to bring a citizen's action in the name of the State of Washington to enforce the Act.
- 2.2 The Thurston County Superior Court has personal jurisdiction over Clallam Co. Democratic Central Committee, a registered political committee in the State of Washington. Clallam Co. Democratic Central Committee's headquarters are located in Clallam County, Washington. It was required to timely file and complete reports of contributions received and expenditures made with the state Public Disclosure Commission (PDC), which is located in Thurston County, Washington. Additionally, the acts and omissions complained of here took place in Thurston County.
  - 2.3 Venue is proper in this court under RCW 4.12.020.
- 2.4 Glen Morgan has obtained standing to carry this case forward for the State of Washington in accordance with the citizen enforcement process set forth in RCW 42.17A.765(4).
- 2.5 Glen Morgan gave written notice of violation of RCW 42.17A by the Clallam Co. Democratic Central Committee to the Attorney General's Office and the Prosecuting Attorney's Office in the county in which the violation occurred. RCW 42.17A.765(4).
- 2.6 Both the Attorney General's Office and the Prosecuting Attorney's Office failed to commence an action within forty-five days after said notice was provided. RCW 42.17A.765(4)(i).

## Failure to file timely or compliant C-4

- 4.6 State law requires that candidates and committees file regular, timely, accurate reports disclosing expenditures, in-kind contributions, debts & obligations, and pledges. RCW 42.17A.235(2).
- 4.7 "Expenditure" includes a payment, contribution, subscription, distribution, loan, advance, deposit, or gift of money or anything of value, and includes a contract, promise, or agreement, whether or not legally enforceable, to make an expenditure. "Expenditure" also includes a promise to pay, a payment, or a transfer of anything of value in exchange for goods,

services, property, facilities, or anything of value for the purpose of assisting, benefiting, or honoring any public official or candidate, or assisting in furthering or opposing any election campaign. For the purposes of this chapter, agreements to make expenditures, contracts, and promises to pay may be reported as estimated obligations until actual payment is made. RCW 42.17A.005(20).

- 4.8 The report disclosing expenditures, in-kind contributions, debts & obligations, and pledges is entitled "Campaign Summary, Receipts and Expenditures" and is designated by the PDC as form C-4, pursuant to WAC 390-16-041.
- 4.9 This report is due monthly until the twenty-first day of the month before an election at which time the report is due twenty-one days before the election, seven days before the election, and on the tenth day of the month following the election. RCW 42.17A.235(2).
- 4.10 Further, candidates and committees must properly break down their expenditures to include certain sub-vendor information. WAC 390-16-205. Committees must also report debts and obligations. RCW 42.17A.240. The committee failed to abide by these requirements.
  - 4.11 Below is a table detailing late C4 filings.

## File a Formal Complaint - Glen Morgan

<u>Glenmorgan89</u> reported (Tue, 19 Sep at 11:11 PM) via Portal Meta To Whom it May Concern --

It has come to my attention that the Clallam County Democratic Central Committee has habitually and willfully committed frequent and multiple violations of RCW 42.17A.

This notice and the attached spreadsheet detail numerous apparent violations of various provisions of Washington's campaign finance law by the Clallam County Democratic Central Committee. The Clallam County Democratic Central Committee has apparently violated RCW 42.17A as follows:

# 1) Failure to file accurate, timely C3 and C4 reports. (Violation of RCW 42.17A.235)

State law requires that candidates and committees file frequent, accurate reports of contributions, expenditures, in-kind contributions, and debt. Unfortunately, the Clallam County Democratic Central Committee has failed on numerous occasions to do this. (See Exhibit A – "Illegally Late filed C3 and C4 reports").

Cumulative total for reports past statutory deadline is 1,982 days late.

# 2) Failure to accurately, timely report debt. (Violation of RCW 42.17A.240 (8), see WAC 390-05-295)

State law requires that the name and address of any person and the amount owed for any debt, obligation, note, unpaid loan, or other liability in the amount of more than two hundred fifty dollars or in the amount of more than fifty dollars that has been outstanding for over thirty days be reported on form C4. Per WAC 390-05-295, this includes any oral or written order placed, debt or obligation to purchase goods or services or anything of value, or any offer to purchase advertising space, broadcast time or other advertising related product or service.

The Clallam County Democratic Central Committee illegally failed to report the following debts: (See Exhibit B - "Illegal failure to timely report debts").

Cumulative total for reports that did not properly report debt is 14,417 days late and counting.

3) Failure to properly break down expenditures. (Violation of RCW 42.17A.235, see WAC 390-16-205)

State law requires that expenditures made on behalf of a candidate or political committee by any person, agency, firm, organization, etc. employed or retained for the purpose of organizing, directing, managing or assisting the candidate's or committee's efforts shall be deemed expenditures by the candidate or committee and reported as such. In accordance with WAC 390-16-037, such expenditures shall be reported by the candidate or committee as if made or incurred by the candidate or committee directly.

The Clallam County Democratic Central Committee illegally failed to break down the following expenses. (See Exhibit C - "Illegal failure to break down expenditures")

Cumulative total for reports that illegally failed to break down expenditures is 13, 429 days late and counting.

The PDC should investigate the possibility that the Clallam County Democratic Central Committee committed the above violations maliciously, which would be a class C felony per RCW 42.17A.750 (2)(c). If the PDC determines that is the case, they should refer the case to the Attorney General's office for criminal prosecution immediately.
