To whom it may concern,

It has recently come to my attention as I was surfing the PDC reports last night that the Skamania County Democrats appear to have egregiously violated Washington State's campaign finance laws (**RCW 42.17A**). The details of these violations are as follows:

1) Possible theft of funds, missing money, and secret cash stashes, possible misuse of the disappearing funds for someone's personal use (Violation of RCW 42.17A.445)

In several instances, this secretive party PAC seems to have "vanished" campaign funds. They could be stolen for personal misuse – maybe someone decided to hit the casino and betted poorly on red. Perhaps someone stole these funds and used them at the local pot shop. Right now, we just don't know, so only a deep dive into the finances of this organization will reveal the truth.

Let's start with the final C4 (expenditure report) filed by this crew at the end of the 2000 calendar year (See PDC C4 Report # 110004432, attached for staff reference). Supposedly, according to this report, this PAC claims they had \$1,998.33 in the bank account (see line 18). This was as of December 31, 2000, according to this PAC. However, the very next day – January 1, 2021 (See PDC C4 Report #110007908, attached for staff reference), this PAC claims they had zero dollars in the bank account? Where did the \$1,998.33 go? Nobody knows. The public clearly doesn't know, and these guys aren't reporting the truth right now. Something happened to this cash. Who got the cash? Was it stolen? Was it secretly given to a politician "off the books?" Who knows? But the truth around these missing funds needs to be resolved.

Another example, this time mystery appearing funds with no explanation. At the end of 2022, this PAC filed two different C4s – neither one was an amended C4, so it isn't clear which one is the accurate one. Regardless of which one this PAC claims to be accurate, they both indicate a problem. The first C4 claimed this PAC had \$5,108.80 in the bank (line 18) (See PDC C4 Report # 110130799, attached for staff reference). The second C4, again not appearing to amend the first one, just a new C4 claims this PAC had \$5,183.80 in the bank (See PDC C4 Report # 110130800, attached for staff reference). However, regardless of which C4 is the real C4 from this PAC, they both expose a real problem here, because the first C4 filed by this crew (filed several months late, I might add – which is another separate violation of RCW 42.17A.235 & .240) claims that this PAC started the year with \$5,866.89 in the bank (See PDC C4 Report # 110142658, attached for staff reference). Keep in mind, whether this PAC suddenly "discovered" \$758.09 or \$683.09, there is something wrong here. Where did this secret stash of mystery cash come from? Who gave it to them? Was it off the books contributions? Concealed from the public? Is it illegal overlimit anonymous contributions (A clear violation of RCW 42.17A.220(4))? Nobody knows and it doesn't seem like these guys are talking.

A clear indicator that someone is either making numbers up or just falsifying the documents they are submitting to the PDC is when a C4 report reflects a negative balance on Line 18. This is a clear red flag that something is wrong. As the PDC so clearly explains in their guidance, helpfully listed in black and white right below Line 18 on every C4 report for the past few decades "Line 18 should match the bank account balance(s) and petty cash balance(s)." It would be impossible for an honest PAC or candidate to report a negative number in Line 18 on a C4 report if they were reporting the truth. A negative number here is indicative of a faulty and false report. An example of this group doing this, for example would be a C4 apparently filed 117 days late with a negative balance of \$2,402.57 (See PDC Report # 4906322, attached for

staff reference). Not only did they conceal the truth about the \$1,597 of reportable transactions concealed from the public for 117 days, but the report is obviously fake and fraudulent with a negative balance reported on line 18.

Here are some more examples:

PDC Report #4906326 – late filed and a negative balance again of \$2,402.57 PDC Report # 4906318 – filed months late and a negative balance of \$805.48

2) Illegally concealing the truth from the voters by filing reports substantially late, sometimes after the election is over (Violation of RCW 42.17A.235, .240)

This PAC also has frequently filed reports late. It is just habitual with this crew. However, it is hard to really figure out what is happening here. Due to the C4 reports indicating odd balances that are obviously fake or dishonest (negative numbers or missing funds or surprise secret stash cash piles – see Allegation #1 above), the attached partial list of late reports is just for PDC staff reference based on an initial assessment of the problems this PAC has with accuracy, truth, honesty, or even marginal levels of compliance. Concealing the truth about the expenditures this Pac has made over the years is a real habitual problem.

The first spreadsheet I've attached, as always has links in the far right column to the original late report. I've highlighted the egregiously late reports in red. The problematically late reports in orange (14-5 days) and the sloppily late reports (4-1 day) in yellow. This should provide the respondent the proper focus in explaining the apparent late reporting and is intended as a reference sheet for them to use and perhaps assist them as they sort out the missing funds and where they went. Please note none of these appear to be amended reports. They are all original. Some of the small dollar reports are C4s still showing negative balances on Line 18. Again, for PDC staff and the lawbreakers convenience, I have attached this file in both Excel and PDF formats.

The second spreadsheet is different than what I've provided to the PDC in the past, but I've highlighted the particularly troubling late reports, which I believe on their own justify this allegation and requiring the respondent to clarify exactly what the heck is going on here. The yellow highlights in this spreadsheet are the reports, which on their own would justify filing a complaint about the egregious nature of the lawbreaking at this PAC.

Again, I can't possibly see how to sort out the truth with this lawbreaking crew without filing formal subpoenas on their bank records (See RCW 42.17A.160). This is just a classic example where subpoenas will save lots of staff time, speculation, and drama so that staff can truly quantify the magnitude of the lawbreaking with this crew.

3) Failure to accurately describe expense, and the illegal concealment of required information from the public. (Violation of RCW 42.17A.240, RCW 42.17A.235 & WAC 390-16-037)

Once I realized this PAC would so egregiously violate the law with such reckless disregard for the public to know the truth about their secretive efforts to influence elections, I kept looking closer. It turns out this PAC has failed to follow Washington State's Campaign Finance laws as they apply to the reporting of expenditures (of course). Here are a few specific examples of failing to follow the law. These are clear and explicit violation of WAC 390-16-037:

- On PDC Report # 110066643, attached for staff reference, this PAC claims to have spent \$176.40 on newspaper ad without legally required details. When was the ad run? What size of ad? What was the ad for? Was it for a candidate? This is an explicit violations of WAC 390-16-037, Example A.
- On PDC Report # 110113614, attached for staff reference, this PAC claims to have spent \$193.20 on newspaper ad without legally required details. When was the ad run? What size of ad? What was the ad for? Was it for a candidate? Again, this is an explicit violations of WAC 390-16-037, Example A.
- On PDC Report # 110151793, attached for staff reference, this PAC claims to have spent \$650.36
 on some type of printing for a politician. Once again, no details provided. How many pieces
 printed? What was it? Again, another clear and obvious violation of WAC 390-16-037, Example B.
- On PDC Report # 101006426, attached for staff reference, this PAC claims to have spent \$968.63 on "ad." Once again, no details provided. How many ads? What size? Ad for whom? Promoting which politician? Seriously, just sloppy and lazy and illegal. A clear violation of WAC 390-16-037, example A
- On PDC Report # 110003125, attached for staff reference, this PAC claims to have spent \$645.75 on "ad." And another \$630.00 on "ad." Once again, no details provided. How many ads? What size? Ad for whom? Promoting which politician? Slipshod, sloppy and lazy and illegal. A clear violation of WAC 390-16-037, example A
- On PDC Report # 101010585, attached for staff reference, this PAC claims to have spent \$500 on "ad for 2 weeks" which weeks? What date, for whom?, another \$709.50 for "one week ad" which week? What size? What date range? For whom?, and they also accepted multiple in-kind contributions of campaign signs from the WA State Dems for Biden, but they fail to specify the number of signs again, this report has clear violations of WAC 390-16-037, Example A & B

Fortunately, resolving these violations and the other similar violations in this specific allegation is pretty simple. This PAC just has to go back and correct all the C4 reports where they have attempted to conceal critical information from the public and violated **WAC 390-16-037**. This might be easier than trying to sort out where the missing funds went and how the secret cash stash appeared in the bank account, and all those negative balances on Line 18. Compared to that, fixing these deficiencies spelled out in this one allegation should be simple.

In the end, this PAC needs to face up to the fact that they could really benefit from a professional treasurer and compliance crew. They clearly have been managing large piles of cash, so they have the resources to pay professionals to do it right.

If they discover someone stole the funds, or they have lost the missing funds, they need to come clean about what exactly happened here. It might be embarrassing, but they are not the first group to have something like this happen to them.
