To whom it may concern,

It has come to my attention that the Whitman County Democratic Central Committee has violated Washington State's campaign finance laws (**RCW 42.17A**) for many years now. The details are as follows:

1) Failure to file C1PC report annually as required to retain mini-reporting status (Violation of RCW 42.17A.205, WAC 390-16-115(4))

As the law so clearly states in **WAC 390-16-115(4)**, a PAC which chooses to file for mini-reporting status and enjoy all the privileges this status conveys upon their activities to avoid public scrutiny is still required to refile a new C1PC (statement of organization) every year. In fact, they are required to file a new one every year between January 1st and January 31st of that year.

Unfortunately this PAC has failed to file a new C1PC report with the PDC since 2016 (see attached for staff reference).

I hope this PAC can come back out of the shadows and become compliant with campaign finance laws once again.
