To whom it may concern,

It has come to my attention that the Whitman County Democratic Party has committed additional violations of Washington State's Campaign Finance Laws (**RCW 42.17A**). The details are as follows:

1). Theft or misappropriation of campaign funds for personal use (Violation of RCW 42.17A.445, WAC 390-16-238, RCW 42.17A.240, RCW 42.17.235)

I realize that a current investigation is ongoing into other shady illegal behavior by this secretive political party PAC (See **PDC Enforcement Case #142460**), however this is an entirely different set of problems uncovered with a casual review of this organizations Non-Exempt PAC. As such, it seemed appropriate to break this into a different investigation since this PAC seems to have some problems following the law.

The first thing that really jumped out at me was the missing cash stash that appears between the end of the 2020 campaign and the beginning of the 2021 campaign. It appears that \$250 ended up in someone's pocket, and these guys are keeping the lucky recipient of this cash stash a secret from the public and the PDC.

Specifically, if you look at the final C4 filed by this secretive and shady PAC (See PDC C4 Tracking #110004392, attached for staff reference) you will note that the final ending balance that year reported on line 18 was \$3,047.48. But, when the next month's first C4 report was produced (See PDC C4 Tracking #110007611, attached for staff reference), the starting balance was light in the loafers by about \$250. It isn't clear who got away with the cash, but regardless of who stole it or lost it or where it went, this crew needs to confess and expose the truth. I know that when organizations operate in darkness, it is challenging for them to come out into the light, but I'm confident that they can do it if they really want to.

I realize this group is already under investigation for other lawbreaking, but this is really a separate violation from that original investigation.

Let me know if you need anything else on these guys.
