Complaint Description
Wallacecharlesr reported via the portal <i>(Wed, 11 Oct 2023 at 4:09 PM)</i> On June 22, 2023; the City Council in Longview Washington approved Resolution No. 2455 to allow City of Longview voters to decide whether to create the City of Longview Metropolitan Park District. On September 24, 2023; I observed a campaign style signage begin to appear. The green in color signs with black in color lettering read VOTE YES PARKS. A search for any Political Action Committee (PAC) registered within the State of Washington, in Cowlitz County, in the calendar year 2023 , on the State of Washington PDC website met with negative results. There are about twenty locations where this VOTE YES PARKS signage appears with the city limits.
What impact does the alleged violation(s) have on the public?
By failing to register with the State of Washington PDC, this campaign / PAC: * Is not transparent in the politics involved with this PAC. * PAC fund raising activity is concealed that will lead to unnecessary speculation within the community. * PAC does not provide a path for local legitimate media outlets to contact representatives from this campaign, for the purpose of reporting information to the public. * Acts as a disservice to efforts by City of Longview in polling voters on a important issue facing this city by encouraging unnecessary speculation.

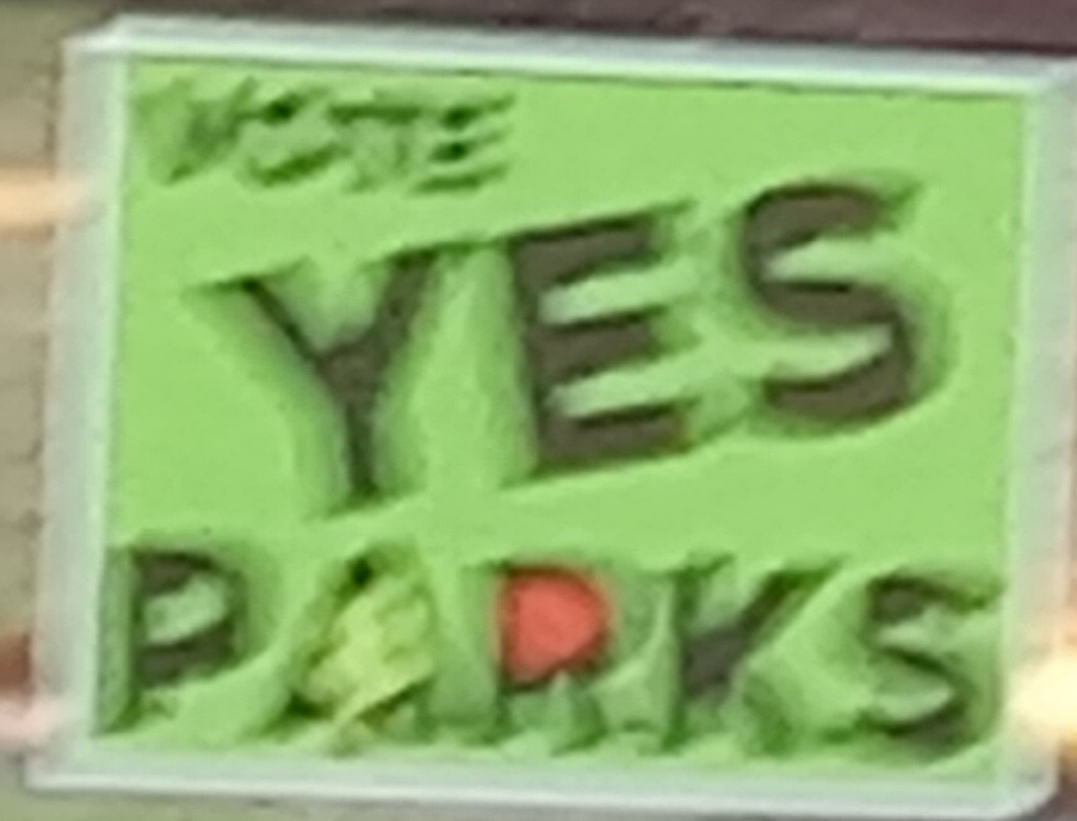
