On October 7, 2023, Annette Rose, an individual, posted a photo of campaign signs on Facebook (Exhibit 1). One campaign sign is for Michael Connors, a candidate for Kennewick School Board. Two other signs point arrows toward the Michael Connors sign and state: "Voted with Liberals 100%" and "Kept Our Kids In MASKS".

Exhibit 2 shows another sign with arrows pointing to a Michael Connors sign that states: "Supports CRT in Schools".

Exhibit 3 shows "Paid for by We Want Accountability PAC" on the signs.

Exhibit 4 is a Facebook screenshot from May 1, 2022, where Annette Rose shares a photo of a campaign sign for a school board candidate with a small sign adjacent that reads "VOTED TO MASK YOUR CHILD" with an arrow pointing to the candidate's sign. Annette Rose comments "We need to get some of these signs made up for future elections... specifically anyone on the school board who thinks they're going to stay in office." Micah Valentine, a current Kennewick School Board Director, replies with "Love this!"

Each of these signs appears to be a violation of RCW 42.117A.335(1)(a):

- (1) It is a violation of this chapter for a person to sponsor with actual malice a statement constituting libel or defamation per se under the following circumstances:
- (a) Political advertising or an electioneering communication that contains a false statement of material fact about a candidate for public office;

Claim: "Voted with Liberals 100%"

This statement is verifiably false. In a July 2022 radio interview on the Lars Larson Show, Kennewick School Board Director Micah Valentine stated, "Gabe and I, we ran specifically on a CRT platform...we ran specifically on that platform and we won...so the people spoke. At this point, our board is essentially we have two conservatives and three leftists. And those three leftists are absolutely lock-step and they've never not voted together." (Source: https://soundcloud.com/thelarslarsonshow/micah-valentine-at-least-one-nw-school-board-is-acting-to-protect-kids-from-crt)

Accordingly, the "Liberals" on the board are supposedly Michael Connors, Ron Mabry, and Diane Sundvik, and the "Conservatives" are Gabe Galbraith and Micah Valentine.

One example proving this claim false is from the board minutes dated April 12, 2023 (Exhibit 5). A motion was made by Gabe Galbraith to accept Resolution No. 6, 2022-2023: WSSDA Weighted Vote Removal Resolution which was seconded by Micah Valentine. The roll call vote was Mr. Connors: Yes; Mr. Mabry: Abstain; Ms. Sundvik: No; Mr. Valentine: Yes; Mr. Galbraith: Yes.

Further, per Micah Valentine's own website, in February 2019 he wrote:

"Kids should be in school. At the time of this post, the Kennewick School Board is not doing their job. Their job is to protect kids and they are not doing that. Click to see the members. We need more members like Michael Connors.

Members who voted to keep kids out of school.

- Diane Sundvik
- Dawn Adams
- Ron Mabry

We need to vote them out. We should also replace Heather Kintzley."

Mr. Valentine's own blog post contradicts the statement he made in the radio interview, and this is further evidence of the political advertisement's falsehood.

Claim: "Kept Our Kids in MASKS"

This is a false statement. A unanimous opinion was issued by the Supreme Court of the State of Washington in the matter of the recall of three Richland School Board directors on April 27, 2023. That ruling notes that "state statutes give the governor and the secretary of health the power to mandate masking pursuant to their authority under a state of emergency, and the local school board did not have the power to override that state-level action." Further, it concludes the Richland School Board's "decision to vote to remove the mask mandate was not within the board's discretionary power." Therefore, it was clearly not within the authority of Michael Connors individually nor the Kennewick School Board as a whole to remove masks from students in the district during the Governor's state of emergency.

Further, at no point was a motion made during a Kennewick School Board meeting to make masks optional or otherwise. The "Conservative" board members could have made a motion at any time but declined to do so.

Claim: "Supports CRT in Schools"

This is a false statement. On August 24, 2022, the Kennewick School Board (including Michael Connors) unanimously passed Policy 2340, INSTRUCTION: Race and the

Curriculum (Exhibit 6). One week later, on August 29, 2022, the Washington Policy Center posted a blog entitled "Kennewick School Board votes to protect children from Critical Race Theory racism"

On September 1, 2022, Micah Valentine posted on Facebook celebrating "#noCRT" and included links and screenshots from national media attention that declared "Kennewick School District in Washington State has voted 5-0 to ban critical race theory from the curriculum." (Exhibit 7) It stands to reason that if Michael Connors voted for Policy 2340 which was celebrated as a ban on critical race theory, he does not support CRT in schools.

Year to date, Annette Rose has donated \$600 to the We Want Accountability PAC. The Benton County Republican Central Committee has donated \$4,000. The Benton County Republican Central Committee has endorsed the opponent of Michael Connors. (Source: https://www.bcrpwa.com/endorsements-7623)

These signs paid for by the We Want Accountability PAC are a blatant attempt to deceive the public. These false statements are material as they attempt to portray Michael Connors as a "liberal" candidate to harm him politically to the benefit of their preferred candidate.

What impact does the alleged violation(s) have on the public?

The violations deceive the public about a candidate.

SUPERINTENDENT/BOARD MEMBER REPORT

Superintendent Dr. Traci Pierce reported that new administrators and our new student Board Representative, London Moody, would be introduces at the September 14 School Board Meeting. Dr. Pierce shared that Staff Professional Days would occur Friday, Monday, and Tuesday, and that the annual All Staff Welcome Back event would be held Tuesday morning. She invited Board members to attend. She added that the district provided a Kindergarten Kick-Off for many of the incoming kindergartens and that many high schools do a "freshmen only" day on the first day of school, August 31.
