<p><u>Albert Schreiber</u> reported via the portal <i>(Thu, 19 Oct 2023 at 9:44 PM)</i></p> <p>The law is very clear and quite precise. WAC 390-18-040 (1) The term "reelect" when used in an advertisement represents that the candidate is presently holding the office being sought, was elected to it, and is seeking another term in that same office in the same district or political subdivision. False political advertising defined is a false statement of material fact about a candidate, or falsely represents that a candidate is an incumbent.</p>
What impact does the alleged violation(s) have on the public?
<p>The unlawful use of the term "Re-Elect" in an attempt to mislead the public into thinking that the candidate Debora Nelson has been elected to the position. Larry Longley is the former chairman & incumbent commissioner in at-large position 6. Debora has not been in position 6 or any at-large position and has never been elected as a commissioner to the NCRFA. She was appointed by the City Arlington to a temporary seat. The fraudulent and deceptive signs together with the information submitted & published are an attempt to hoodwink the public in an attempt to steal an election.</p> <p>This deception has had a detrimental effect on the integrity of our elections. The public should be informed of the deception and the false and fraudulent signs should immediately be removed.</p>
