| <p>Misleading voters/committing a fraud on voters with deceitful practices that are intended to mislead voters through the election process with brazen violations of these RCW's. The coordination between the publication and the candidates running for the school board is a clear violation. These contributions also exceed the limits set to require notice of sponsorship. All of this, setting aside the hate speech personally written by both candidates in the publication that was sent to 6,000 constituents specifically in their districts. The value of these coordinated actions well exceed the limits outlined in the PDC rules. This also has had a major impact/backlash towards the new publication called The Wenatchee World due to the attempt to resemble to established publication.
