I recently received a letter from the "Wenatchee Values Alliance" endorsing candidates Tricia Cleek and Randy Smith for the local school board election. A flyer was included with the letter, and the flyer does not have information on who sponsored the flyer. I researched Tricia Cleek and Randy Smiths' Campaign on the PDC website and was unable to find the Alliance listed as a contributor to their campaigns, unable to find the Alliance listed as a Political Committee and I could not find that the purported Alliance chairman, Bill Sullivan, had expressly donated to the candidates' campaigns.

It is unclear who sponsored the included flyer and whether the endorsed political candidates are part of the "Wenatchee Values Alliance" themselves. I contacted the local UPS Store who confirmed the address listed on the letter is a mailbox at their site. There is no information on the internet or social media that provides insight on this purported Alliance. Outside of mailing a letter or assuming the Alliance's listed Chairman is the same Bill Sullivan sitting on our local health board voters are unable to access information on who might have sponsored the letter or flyer. It's confusingly problematic to try to follow the money and understand the scope of this campaign in support of Tricia Cleek and Randy Smith. Regardless, I have included the correspondence I received.



While Wenatchee schools hollow, local private schools are bursting at the seams with more private schools planned. Many parents have taken their children out of Wenatchee schools and are transporting them to Cashmere and Eastmont.

Other parents, including teachers, have taken their children out of the schools and are home schooling. One former Middle School teacher told us she resigned her teaching position, took her three children out of the schools, and is home schooling. When asked why she took such a dramatic step, she said, "I would never put my children back in Wenatchee schools. What they are doing to children in the name of gender and sexuality is criminal. I will never go back to that system."

Section 3211-P of the Wenatchee School District (WSD) Policies and Procedures Manual, available on the District web site, provides for boys who "identify" as girls to use girls bathrooms; and boys who "identify" as girls to use girls locker rooms; and bunk with girls on field trips.

The existing Board has sacrificed academics in favor of harmful social programs: Critical Race Theory (CRT), Diversity/Equity/Inclusion training (DEI), Transgender Ideology (LGBTQ), Social Emotional Learning (SEL) down to first grade, and now—Tele-therapy for students. Yes, the district just signed a contract with a San Francisco company, Daybreak Health, to provide *telephone psychotherapy* to Wenatchee school children ages 10 and older. Does WSD intend to educate our children, or re-educate them?
