The mail piece was "Sponsored by The Snohomish Ebony PAC." Setting aside the factual inaccuracies of this advertising, the mailing was produced in blatant violation of Washington State laws and Public Disclosure Commission requirements summarized by the following:</p> <p><b>1. Coordination between Demi Chatters and the PAC.</b></p> <ul style="list-style-type: none"> <li>First and foremost, the supported candidate, Demi Chatters, is listed on the PAC's PDC registration (Exhibit 3) and most recent filings as its Treasurer (Exhibit 4). A Treasurer is responsible for reporting all contributions and expenditures (see RCW 42.17A.235). PAC's may not coordinate political advertising with campaign committees. Serving as both Treasurer of the PAC - <u>and</u> the candidate that benefited from the PAC's advertising - is clearly coordination.</li> <li>The campaign mailer sent by the PAC is remarkably similar to two previous mailers sent by the candidate. Same image, same use of campaign logo, same color font, etc. Placed side-by-side, as in Exhibit 5, they appear indistinguishable. Exhibit 6 includes the reverse to see which mailer was from the candidate vs. the PAC.</li> <li>Further evidence of coordination is that the image used does not exist in the public domain. While a similar version is available on the candidate's website (Exhibit 7), this version contains text and a "donate today" button over it parts that are scenic in the mail piece, meaning the PAC and candidate would have had to facilitate the transfer of an original image file not available in the public domain.</li> </ul> <p><b>2. Public Disclosure Reports not filed.</b></p> <ul style="list-style-type: none"> <li>The PAC did not file PDC Form C6 for Independent Expenditure Ads (Exhibit 8) as required (Exhibit 9).</li> <li>The PAC has not reported any of their income or expense activity for over 2 months. Last reports filed 8/6/23 (Exhibit 10).</li> <li>Again, as Treasurer of the PAC, it is Demi Chatters' responsibility to file all public disclosure reports on time.</li> </ul> <p><b>3. Required information withheld from public.</b></p> <ul style="list-style-type: none"> <li>The PAC did not list their top 5 contributors on the mail piece (Exhibit 2) as required (Exhibit 11).</li> </ul>
<b>What impact does the alleged violation(s) have on the public?</b>
Disregarding campaign laws deprives the public of understanding who is funding candidates for elected office. Voters in Everett are not being deprived of complete information of who is funding campaign advertising from a PAC who's Treasurer is the candidate supported by the mailings.

## **Notice of PDC Violations by 2023 Everett City Council Candidate Demi Chatters**

Background: Everett voters received a political mail piece on 10/23/2023 and 10/24/2023 (Exhibits 1 & 2) in support of Everett City Council candidate Demi Chatters. The mail piece was "Sponsored by The Snohomish Ebony PAC." Setting aside the factual inaccuracies of this advertising, the mailing was produced in blatant violation of Washington State laws and Public Disclosure Commission requirements summarized by the following:

### **1. Coordination between Demi Chatters and the PAC.**

- First and foremost, the supported candidate, Demi Chatters, is listed on the PAC's PDC registration (Exhibit 3) and most recent filings as its Treasurer (Exhibit 4). A Treasurer is responsible for reporting all contributions and expenditures (see RCW 42.17A.235). PAC's may not coordinate political advertising with campaign committees. Serving as both Treasurer of the PAC - and the candidate that benefited from the PAC's advertising - is clearly coordination.
- The campaign mailer sent by the PAC is remarkably similar to two previous mailers sent by the candidate. Same image, same use of campaign logo, same color font, etc. Placed side-by-side, as in Exhibit 5, they appear indistinguishable. Exhibit 6 includes the reverse to see which mailer was from the candidate vs. the PAC.
- Further evidence of coordination is that the image used does not exist in the public domain. While a similar version is available on the candidate's website (Exhibit 7), this version contains text and a "donate today" button over it parts that are scenic in the mail piece, meaning the PAC and candidate would have had to facilitate the transfer of an original image file not available in the public domain.

### **2. Public Disclosure Reports not filed.**

- The PAC did not file PDC Form C6 for Independent Expenditure Ads (Exhibit 8) as required (Exhibit 9).
- The PAC has not reported any of their income or expense activity for over 2 months. Last reports filed 8/6/23 (Exhibit 10).
- Again, as Treasurer of the PAC, it is Demi Chatters' responsibility to file all public disclosure reports on time.

### **3. Required information withheld from public.**

- The PAC did not list their top 5 contributors on the mail piece (Exhibit 2) as required (Exhibit 11).

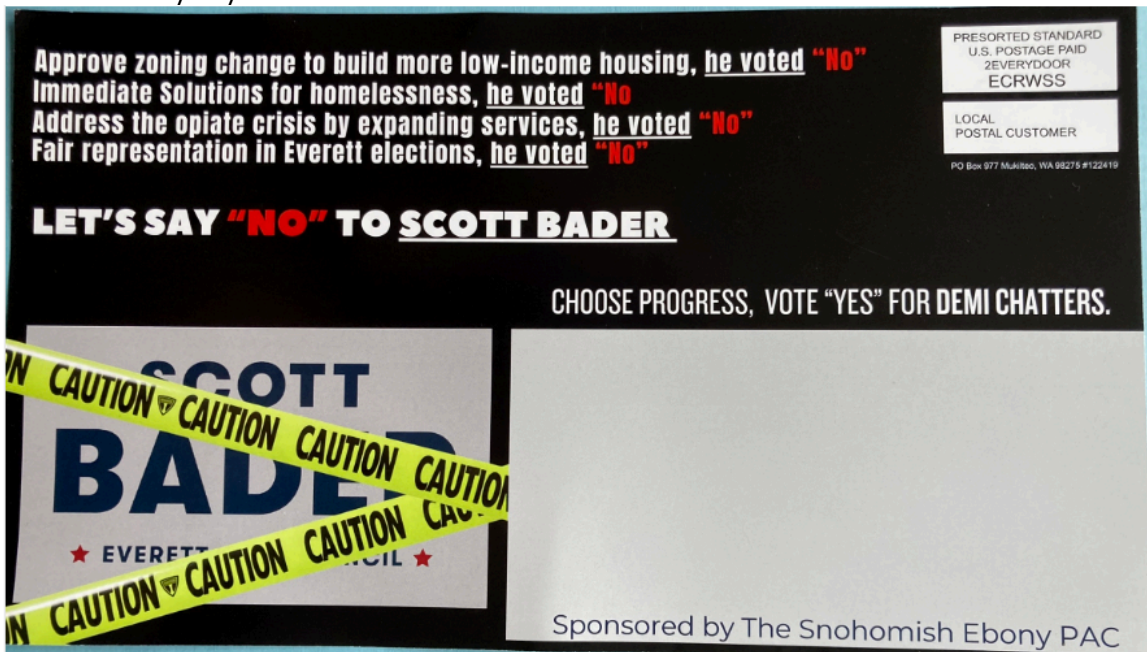

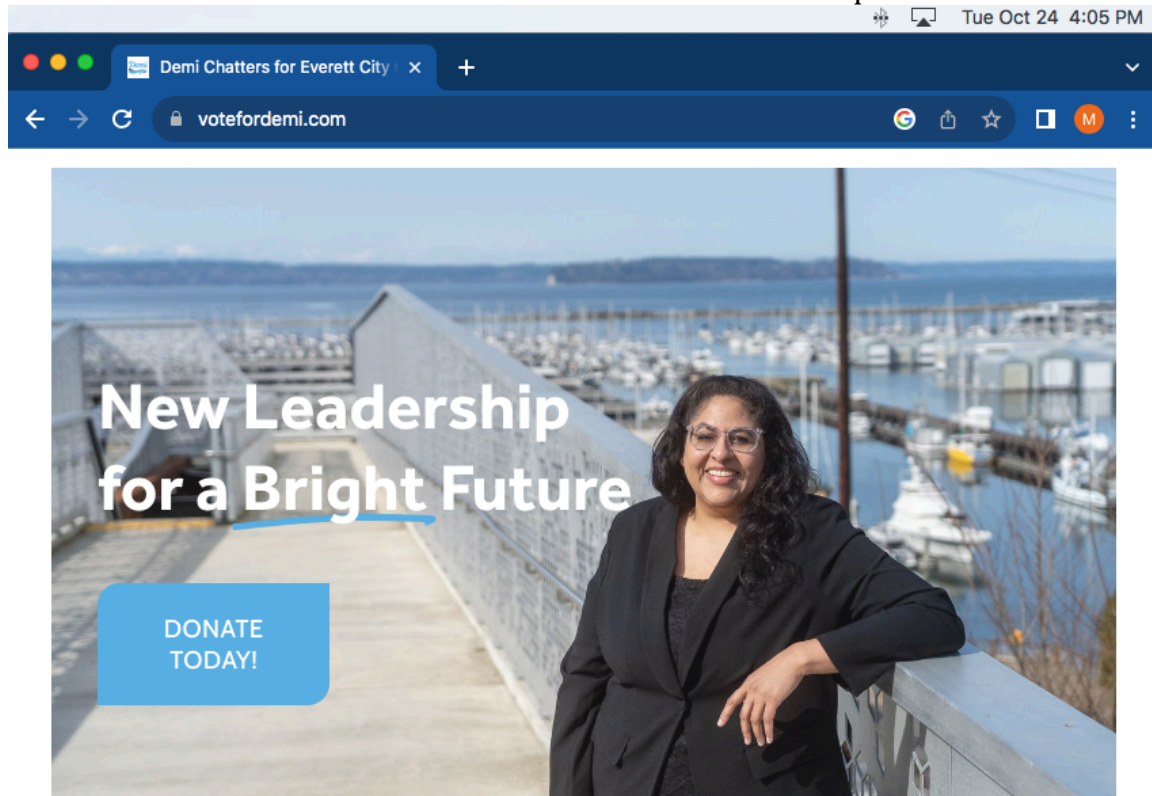
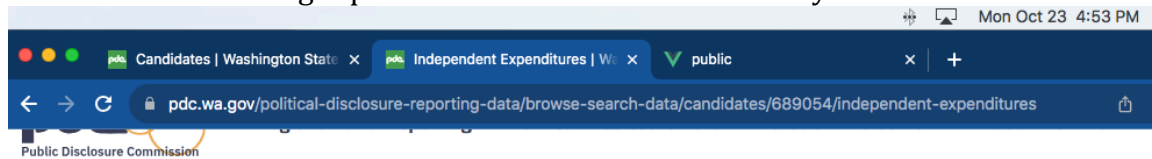

How To Report

### Reporting Independent Expenditures

Any individual, business, union, organization or other person who makes independent expenditures totaling \$1,000 or more supporting or opposing a candidate or ballot measure must submit a [C-6](#) to the PDC within 5 days and then on this schedule:

- on the 10th of the month preceding the election\*
- 21 days prior to the election\*
- 7 days prior to the election\*
- on the 10th of the month after the election\*.

*\*Only file reports when expenditures have been made since the last report.*

The exception are political committees, which report IEs on their regular expenditure reports (C-4s) unless the independent expenditure requires expedited reporting because of its size and proximity to the election.

If an IE is advertising that meets both of the following conditions, the sponsor must report it on a C-6 within 24 hours of, or on the first working day after, the date the ad was published, mailed or made public:

- The ads are valued at \$2,000 or more, and
- are presented to the public within 21 days of an election.

Additional independent expenditure ads presented during this 21 days -- costing any amount -- must be reported on a C-6 within 24 hours of, or on the first working day after, the date the additional ad is first published, mailed or made public.

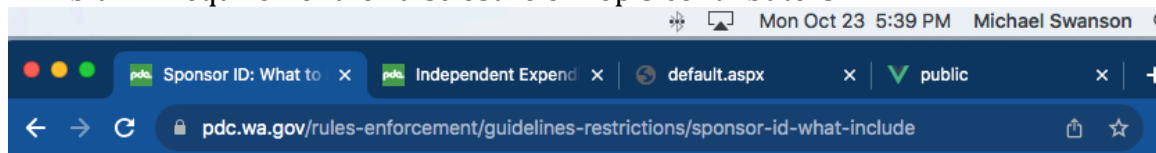

### Sponsor ID required information

A sponsor's address is required for print ads and websites. For other types of ads, see [Sponsor ID placement and size](#).

A **candidate or candidate committee** sponsoring an ad about the committee uses the words "paid for by" or "sponsored by" followed by the name of the candidate committee.

- *Recommended format: Sponsored by the Committee to Elect John Doe, 876 Main St., Olympia, WA*

An **individual, organization, business or political party committee** must include its name on the ad.

- *Recommended format: Paid for by the Committee for Good Government, 123 Market St., Olympia, WA*

A **political committee that is not a bona fide party** must include its Top 5 contributors' names if the ad qualifies as an independent expenditure, electioneering communication or supports or opposes a ballot measure – and the ad costs at least \$2,000.

- *Recommended format: Paid for by the Committee for Good Government, 123 Market St., Olympia, WA. Top 5 Contributors...*
