To whom it may concern,

It has come to my attention that Seattle City Council candidate Kate Martin has committed violations of Washington State's campaign finance laws (RCW 42.17A). The details are as follows:

1) Complete failure to accurately report expenditures (Violation of RCW 42.17A.235, .240)

This failed Seattle City Council candidate during her 2019 campaign appears to have falsified her C4 (expenditure report) by claiming to have spent \$5,062,019 on "food for campaign event" at "La Conasupo" restaurant in Seattle (See PDC C4 Tracking # 100910201, attached for staff reference). While this politician may have frequently wasted and squandered campaign cash on foolish expenditures, it appears unlikely that anyone could buy that much food from that restaurant – even if they bought food for every homeless encampment and drug addict in Seattle for the year, it would be very difficult to squander that much cash on "food for campaign event."

It clearly appears this politician has broken the law by concealing the truth about her campaign's finances in her 2019 campaign. I will also point out for the record that this C4 (expenditure report) clearly indicates a negative balance on Line 18 of \$5, 063.620.45, which is impossible because, as the report itself so clearly indicates – Line 18, MUST match the bank account balance at the time this report was filed. Clearly it did not.

Usually this indicates unreported contributions to the campaign that have not been disclosed to the public, but we can't know for sure until this politician is able to go back and report the truth about what they did with the missing cash stash. In this case, I'd assume that this politician simply reported false information on their massive "food for campaign event." Maybe it is time for her to come clean and tell the truth now?

The violation here is obvious and self-evident. The answer to the questions raised in this complaint are not so obvious. Clearly, this candidate must go back and resolve these questions. It is always better to come clean and tell the truth, so clearly she needs to go back and correct this obviously flawed report.

I realize that this politician is currently being investigated by the PDC for earlier violations she committed which I have reported a few months ago (See **PDC Enforcement Case #141651**), however, that is no excuse to continue to break the law and make it worse now.
