During this campaign for City Council 6 in 2019, I fell behind – and clearly in this case made a clerical mistake - on reporting. When my campaign ended, at the SEEC's recommendation, I hired Jeanne Legault, a professional campaign treasurer, to clean up and amend the reports.

It appears that in her amended C4 report, the \$5,062,029.00 expense at La Conasupo was corrected to \$20.00 which you can see in the web capture below when I search alphabetically for the expense. In other words, it looks to me like the complainant was looking at a C4 report that was later amended with the correct amount.
