Resulting in a miss-representation and/or fraudulent representation of material fact “...I’m reaching out to ...”.</p> <p>The political advertisement is missing “Paid for identification name or address” therefore not allowing the recipient/voter the knowledge, ability or understanding of who is paying for the printing and who is distributing the political advertising in favor of and recommending the two subject candidates.
