What impact does the alleged violation(s) have on the public?

Misipati Semi Bird continues to be a serial violator of the campaign finance laws of this state. In the description below, each instance fails to note the quantities of merchandise, printed items, envelopes, business cards, t-shirts, hats, brochures, signage, hand out cards, stakes, mailers, and other items. We the people deserve to know how much of each item was purchased. Other C4 reports include these quantities but not the ones in the attached document included in the C4s. Semi Bird has failed to file C3s and C4s on time nor record expenditures in an accurate matter. Semi Bird is not a first time candidate and has been warned twice by the PDC. We the people deserve to see law and order. These continued flagrant violations of the law send the message that Semi Bird thinks he is above the law. WAC 390-16-037 shows an example with the quantity displayed. These C4 entries noted below fall short of that standard.
