Subject: Central Valley Citizens for Education Hearing Memorandum: PDC Case 147918

Allegations:

PDC staff alleges Central Valley Citizens for Education (CVCE), a ballot proposition committee supporting the Central Valley School District proposals before voters in the March 2024 special election, violated RCW 42.17A.235 and .240 by failing to timely and accurately file Monetary Contribution (C-3) reports and Summary Full Campaign Contribution and Expenditure (C-4) reports, disclosing contributions and expenditures undertaken by the Campaign as required by campaigns registered under the “Full Reporting” option.

Background:

- Central Valley Citizens for Education has been registered with the PDC dating to 2009.
- During the 2024 February Special Election, a 21-day pre-election C-4 report was due Jan. 23, 2024, that covered the reporting period from Dec. 1, 2023 – Jan. 22, 2024, and a 7-day pre-election C-4 was due Feb. 6, 2024, that covered the reporting period from Jan. 23 – Feb. 5, 2024
- On Jan. 24, 2024, PDC staff received a complaint filed by Conner Edwards alleging Central Valley Citizens for Education violated RCW 42.17A.235 and .240 by failing to timely and accurately file Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contribution and Expenditure reports (C-4 reports), disclosing contributions and

expenditures undertaken by the Campaign as required by campaigns registered under the “Full Reporting” option. **[Exhibit 1]**

- On Jan. 25, 2024, PDC staff received a complaint filed by Dennis Reed alleging Central Valley Citizens for Education violated RCW 42.17A.235 and .240 by failing to timely and accurately file Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contribution and Expenditure reports (C-4 reports), disclosing contributions and expenditures undertaken by the Campaign as required by campaigns registered under the “Full Reporting” option. **[Exhibit 1]**
- CVCE responded to the complaints Feb. 7, 2024 and April 16, 2024. **[Exhibit 2]**
- CVCE filed six reports for the 2024 Special Election, three C-3 reports and three C-4 reports.
- On a C-4 report filed Feb. 4, 2024 CVCE listed \$41,636 cash received during the reporting period, with a Jan. 12 deposit of \$41,636.13. However, there is no corresponding C-3 that shows a Jan. 12 deposit itemizing this contribution. **[Exhibit 3]**
- Staff contacted the Committee via email requesting additional information regarding the contributions. On April 16, 2024, the Committee responded and acknowledged the error, noting the contributions were likely payroll deductions from May 2021 through April 2024 and they are working to gather and file the required PDC reports.
- On March 29, 2024, PDC staff served the Committee by electronic mail, with a hearing notice for a Brief Adjudicative Proceeding to be held May 2, 2024, concerning alleged violations of RCW 42.17A.235 and .240 for failure to timely and accurately file Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contribution and Expenditure reports (C-4 reports), disclosing contributions and expenditures undertaken by the Campaign as required by campaigns registered under the “Full Reporting” option.

Laws & Rules:

RCW 42.17A.235 and **RCW 42.17A.240** require candidates to file timely, accurate reports of contributions and expenditures. Under the “Full Reporting” option, until five months before the general election, C-3 and C-4 reports are required monthly when contributions exceed \$200 since the last report; on the twenty-first day and the seventh day preceding the date of the primary and general election date; and on the tenth day of the first month after the primary and general election date.

Complaint Description
Conner Edwards reported via the portal (Wed, 24 Jan 2024 at 1:11 PM) Description of Complaint This committee failed to timely file a 21 day pre-election C4 by the required deadline (1/23/24). By any objective measure, it is unacceptable that the PDC would take no action to help bring this filer into compliance now that ballots are out to the voters. The PDC has an obligation to provide transparency to the voters by enforcing filing requirements. The agency's failure to actively monitor the filings of committees and enforce filing requirements damages both the public and the committees themselves. I have tried many different times to get the PDC to take action on this type of issue with no tangible results whatsoever. At one point, I believe the agency discussed the possibility of internally flagging non-filers in the PDC's system and proactively reaching out to them to bring them into compliance, but it appears this is not happening. Having exhausted all of my other options to pursue reform, the only remaining option available to me to compel the agency to take action here is to file PDC complaints against these noncompliant filers in an effort to force the agency to take action. By highlighting the agency's failure to meaningfully enforce current reporting deadlines, my hope is that the agency will look to improve its own enforcement procedures and help candidates and treasurers comply with the law. Notice to Respondents: I apologize to you for any inconvenience caused by this complaint; it is not my intention. No campaign treasurer or campaign/committee is perfect. Trying to comply with the myriad of requirements and deadlines the PDC enforces can be extremely difficult, even for those who have been doing this for years. The agency could adopt any number of strategies to help filers "get it right" when it comes to deadlines and other requirements. Some of these strategies might include: a) automated electronic filing reminders to a filer when they have missed a deadline, b) mandatory attendance in a PDC training course before a person is allowed to serve as treasurer, c) giving filers 48 hours to file 21- & 7-day pre-election reports as opposed to the 24 hours candidates currently get, and d) improvements to the ORCA online campaign finance filing system to improve useability. In my opinion, the agency has failed to provide many filers with the knowledge and tools that they need to file reports on time and be compliant. If you are confused by the filing requirements that the agency enforces or are experiencing technical difficulties and/or usability issues with the ORCA system, please be sure to indicate this in your response to the PDC: your comments will provide valuable feedback for the agency.

What impact does the alleged violation(s) have on the public?
Because this committee has not timely filed their required reports, members of the public are unable to view up to date financial information, significantly reducing transparency available to voters. The PDC has an obligation to provide transparency to the voters by enforcing filing requirements. The agency's failure to actively monitor the filings of committees and enforce filing requirements damages both the public and the committees themselves. It is imperative that PDC staff reach out to this committee immediately to bring them into compliance before the 2024 special election is concluded.

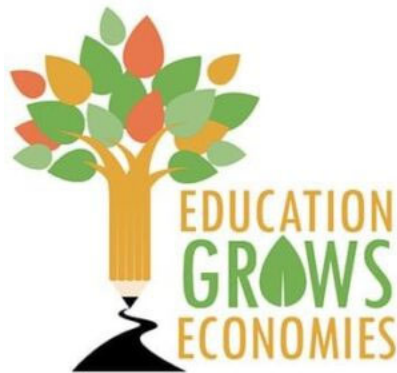
