On Feb 13, ELECTION DAY, he replied to my request with this: "It's all detailed with PDC". That was the complete reply. And as you know PDC website only supplies general info. I believe that as treasurer of the PAC he should have transparently communicated where/how I could actually see the details of the donor info.</p> <p>Codi Roy replied <i>(Wed, 21 Feb 2024 at 7:24 AM)</i></p> <p>Here are copies of my request to Mr. Barnett and the very delayed (on Election Day itself!) answers I was given. When I initially reached out to him on email and didn't get a timely reply, I also sent him a casual message on FB messenger requesting him to check his emails, to which he replied well AFTER Election Day.</p> <p>Thank you!</p>
