To whom it may concern,

It has come to my attention that the 39th Legislative District Democrats, once again, has violation Washington State's campaign finance laws (**RCW 42.17A**). The details of these violations are as follows:

llegally exceeding contribution limits for mini-reporting. Failing to convert to full reporting political committee. Concealing this information from the public (Violation of RCW 42.17A.205, RCW 42.17A.235, RCW 42.17A.240, WAC 390-16-105, WAC 390-16-125)

On at least one occasion, this secretive dark money party PAC accepted a contribution far in excess of the contribution limit from one donor to a mini-reporting campaign (**See WAC 390-16-105(1)(b)).**

Specifically, this campaign received a \$2000 contribution from the Washington State Democrats on 8/23/2023 (See PDC Report # 110172389, attached for staff reference).

There is no evidence of this campaign refunding money to this PAC, nor is there any evidence of this campaign changing filing status from mini-reporting to full reporting (**See WAC 390-16-125** for that process). Just to confirm, I have attached the C-1 which was updated a few days after they received this \$2,000 from the Washington State Democrats.

Please note, this local bona fide Party PAC also has an exempt account, which also converted from mini-reporting to full reporting around the same time, but they didn't report this cash infusion either. I've attached this exempt account C-1 as well for reference.

It appears likely that if this secretive PAC was willing to so openly violate the mini-reporting requirements laid out by the Washington State Campaign Finance laws, there are probably more laws they broke as well, but I'll share those details when I have them sorted out.

Please note, this is a crew with a history of violating Washington States campaign finance laws. See PDC Enforcement Case #26307, which I've attached for staff reference. This was based on a solid complaint I filed at the time in 2017, and the same players are involved. **Back**

then, they were forced to forfeit illegally obtained funds to the state and they were not fined. This time, I hope the PDC considers more stringent penalties this time around.

For now, this should be enough to investigate this crew of lawbreakers.

File a Formal Complaint - Glen Morgan

To Whom it May Concern --

It has come to my attention that the 39th Legislative District Democrats have habitually and willfully committed frequent and multiple violations of RCW 42.17A.

1) Failure to file campaign finance reports electronically. (Violation of RCW 42.17A.245, see WAC 390-19-050(2))

State law requires that committees (who expend \$5000 or more in the previous year or **expect to in the current year**) file their C3 contribution and C4 expenditure reports electronically, using either ORCA, or an alternative reporting software. As such, the 39th District Democrats were required to file electronically.

The 39th District Democrats did not lack the technological ability to file reports using the electronic means provided by the PDC. In fact, in years prior, the Committee did file electronic reports.

RCW 42.17A.245(2) also clearly states: "failure by a candidate or political committee to comply with this section is a violation of this chapter."

It should be clear why the state legislature voted to make this a violation. The Public Disclosure Commission is an agency of limited staff and resources. Allowing committees to file using non-electronic means (even though they possess the capability to use electronic alternatives), creates an even larger burden on PDC staff -- who must scan and proof the documents that are sent to them.

As a result of this illegal method of filing, individuals who seek to view a list of the Committee's donors were greeted with a blank page when searching the PDC's normal database.

The committee must immediately electronically file reports during the period that they illegally failed to do so.

2) State law requires that candidates and committees file regular, accurate, timely C3 and C4 reports. RCW 42.17A.235.

Unfortunately, the 39th District Democrats filed numerous reports well past the appropriate due dates in both 2015, 2016, and 2017. One report appears to have been filed more than a year late. As mentioned before, these reporters were also not filed digitally.

The majority of these late reports lack report #s because they were not filed digitally.

3) State law prohibits committees from accepting more than \$300 worth of anonymous contributions annually, or 1% of the total amount raised, whichever is greater. RCW 42.17A.220 (4). State law also establishes that candidates must return contributions that exceed the contribution limits contained in RCW 42.17A.405 within 10 days of receipt. RCW 42.17A.405, RCW 42.17A.110, WAC 390-16-312.

In 2014, the Committee reported having received \$1639 in anonymous contributions. *(See attachments)*This amount is illegally in excess of the applicable \$300 anonymous contribution limit.

\$1339 was collected illegally by the Committee when it should have been sent to the State Treasurer's Office.

In 2015, the Committee reported having received \$384.00 in anonymous contributions. (See attachments) This amount is illegally in excess of the applicable \$300 anonymous contribution limit.

\$84.00 was collected illegally by the Committee when it should have been sent to the State Treasurer's Office.

In 2016, the Committee reported having received \$990.00 in anonymous contributions. (See attachments) This amount is illegally in excess of the applicable \$300 anonymous contribution limit.

\$690 was collected illegally by the Committee when it should have been sent to the State Treasurer's Office.

In total, \$2113 must be immediately transmitted to the State Treasurer's Office for deposit into the general fund per RCW 42.17A.220 (4). The Committee has illegally refused to transmit these funds for far longer than 10 days of receipt.

3) State law requires that the committee treasurer preserve books of account, bills, receipts, and all other financial records of the campaign or political committee for not less than five calendar years following the year during which the transaction occurred. (Violation of RCW 42.17A.235 (6)). State law further requires that the committee treasurer maintain a list of all individuals contribution no more than twenty-five dollars in the aggregate from any one person during the election campaign. RCW 42.17A.240(2)(c).

On information and belief, the 39th District Democrats have failed to maintain financial records for a period of five calendar years following the year during which the transaction occurred. Specifically, I believe that they have failed to maintain a list of individuals contributing no more than twenty-five dollars in the aggregate from any one person, as specifically required by state law.



The Public Disclosure Commission (PDC) has completed its review of the complaint you filed against the 39th Legislative District Democratic Central Committee on September 30, 2017.

Your complaint alleged that the 39th Legislative District Democratic Central Committee (Committee) may have violated: RCW 42.17A.245 for failure to electronically file C3 and C4 reports when expending \$5,000 or more, RCW 42.17A.235 for failure to timely and accurately file C3 and C4 reports, RCW 42.17A.220 for accepting anonymous contributions in excess of the allowable limit.

You stated in allegation (3), that your allegations were based "On information and belief" but you failed to provide any evidence to substantiate those allegations. Therefore, staff did not review this allegation.

PDC staff reviewed your allegations; the applicable statutes, rules, and reporting requirements; the response from Laura Ewan, legal counsel for 39th Legislative District Democratic Central Committee; and the applicable PDC reports and data in the PDC contribution and expenditure database filed by the Committee, to determine whether the record supports a finding of one or more violations.

Based on staff's review, we found the following:

- The 39th Legislative District Democratic Central Committee is a Bona Fide Political Party Committee for the 39th Legislative District, located in Monroe, Snohomish County.
- The Committee's most recent C1-PC was filed March 3, 2017 and most recently amended Jan. 8, 2018, with the Committee choosing the Full Reporting option and listing Eric Halvorson as treasurer and Karl De Jong as chairman.

- In her response Ewan stated "the Committee acknowledges that as a result of inexperience and misunderstanding of the requirements of the Fair Campaign Practices Act (FCPA) by those responsible for the Committee's reporting requirements during the period in question, not all reports were filed in a timely or sufficient manner. With the commencement of the new treasurer's tenure in 2017, the Committee has addressed its shortcomings and has fulfilled its reporting requirements correctly."
- PDC staff's review found the Committee filed all its reports electronically for the 2017 and 2018 election years.
- In her response, Ewan also stated "RCW 42.17A.220(4) regulates accumulated unidentified contributions 'in excess of one percent of the total accumulated contributions received in the current calendar year, or three hundred dollars, whichever is more...' (emphasis added). In 2016, the Committee did not believe that the total unidentified contributions would surpass the 1% or \$300 cutoff required by law. Any excess was inadvertently retained. We have since submitted that excess to the state treasurer, as required by law, and have implemented procedures to ensure that it will not happen again."
- The Committee reported a March 30, 2018 expenditure to the WA ST Treasurer for \$450.29 for Extra Anonymous contributions over limit 2014-2016.

Based on these findings staff has determined that, in this instance, failure to file all reports in a timely and accurate manner and the acceptance of anonymous contributions in excess of the allowable limit, does not amount to an actual violation warranting further investigation.

PDC staff is reminding the Committee about the importance of filing timely and accurate reports and forfeiting excess anonymous contributions to the State of Washington in future years in accordance with PDC laws and rules.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).
