On March 26, 2024, PDC staff received a completed a Statement of Understanding (SOU) from you acknowledging one violation of RCW 42.17A.235 for failing to timely file the required C-4 report and paying a \$150 civil penalty in accordance with WAC 390-37-143. The SOU and penalty payment allowed staff to resolve the violation in lieu of having a BAP hearing scheduled.

Subject: Complaints filed against 2023 Candidates Bonnie Bowers (PDC Case 149611); James Jeyaraj (PDC Case 149616); Edward Prince Jr. (PDC Case 149614); Rick Glenn (PDC Case 149618); and Jeralee Anderson (PDC Case 149615).

Conner Edwards:

The Public Disclosure Commission (PDC) staff has completed its review of five Respondents listed above as part of the complaints you filed against 2023 candidates that appeared on the November 7, 2023 general election ballot.

These five complaints alleged violations of **RCW 42.17A.235 and .240** for failing to timely and accurately file the 21-Day or 7-Day Pre-General Election Summary Full Campaign Contribution and Expenditure reports (C-4 reports) disclosing contribution and expenditure activities undertaken during the 2023 election cycle. PDC staff found the following:

- On March 15, 2024, both Bonnie Bowers and James Jeyaraj completed a Statement of Understanding (SOU) acknowledging one violation of RCW 42.17A.235 for each candidate for failing to timely file the required C-4 report. Both candidates paid a \$150 civil penalty in accordance with WAC 390-37-143 to resolve the violation in lieu of having a Brief Adjudicative Proceeding (BAP) scheduled.
- On March 25, 2024, Rick Glenn completed a SOU acknowledging one violation of RCW 42.17A.235 for failing to timely file the required C-4 report and paid a \$150 civil penalty in accordance with WAC 390-37-143 to resolve the violation in lieu of having a BAP scheduled.
- On March 26, 2024, Edward Prince Jr. completed a SOU acknowledging one violation of RCW 42.17A.235 for failing to timely file the required C-4 report and paid a \$150 civil penalty in accordance with WAC 390-37-143 to resolve the violation in lieu of having a BAP scheduled.
- On March 27, 2024, Jeralee Anderson completed a SOU acknowledging one violation of RCW 42.17A.235 for failing to timely file the required C-4 report and paid a \$150 civil penalty in accordance with WAC 390-37-143 to resolve the violation in lieu of having a BAP scheduled.

Based on these findings, PDC staff found no evidence of violations that would require conducting a more formal investigation into these complaints or pursuing any further enforcement action in these instances.

The PDC has dismissed all five matters against Bonnie Bowers (PDC Case 149611), James Jeyaraj (PDC Case 149616), (3) Edward Prince Jr. (PDC Case 149614); (4) Rick Glenn (PDC Case 149618); and (5)) Jeralee Anderson (PDC Case 149615,) in accordance with RCW 42.17A.755(1).
