To whom it may concern,

It has come to my attention that the Clover Park Citizens for Schools PAC (2024) has egregiously violated Washington State's campaign finance laws (RCW 42.17A) for many years now. The details are as follows:

1) Concealment of thousands of expenditures and contributions through a variety of election cycles (Violation of RCW 42.17A.235, .240)

When reviewing this PAC it has become obvious that they have concealed the truth about their previous campaign activities for many years, only being forced to reveal the truth a few months ago. The voters and the public were denied access to this information, in many cases for more than 4 years now. While it is better that they finally came clean recently, this doesn't change the fact that this committee willfully concealed the truth from the voters and the public for so many years now.

The vast majority of their reported \$18,106 were reported years late and concealed from the voters and the public during the levy campaigns those funds were presumably spent. I will also point out that the mystery "starting balance" of \$17,903 can't be verified as to the original source of these funds either (See attached PDC C4 Report #110198531, attached for staff reference). In theory, this "starting balance" is based on a previous C4 amount from before, but since there is no way to verify this exists anywhere, this previous balance is unknown. There is no practical way for the public to verify this, but PDC staff can do so if they file a subpoena of the bank statements over these past years and see if anything matches.

This is just another case where the public has been kept in the dark for years by the activity of the previous actions of the people running this PAC and previous treasurers. Obviously, they decided to hire a real treasurer to clean up this mess, but these previous treasurers should also be held accountable for their willful failure to even pretend to comply with Washington State's campaign finance laws.
