<p>Glen Morgan</p> <p>Mon, 29 Apr 2024 at 5:06 PM</p> <p>To whom it may concern,</p> <p>It has come to my attention that the Electrical Workers 46 PAC, sponsored by IBEW Local 46 has violated Washington State's campaign finance laws (RCW 42.17A). The details are as follows:</p> <p>1) Failure to report contribution to politician (Violation of RCW 42.17A.235, .240)</p> <p>According to incumbent 47th Legislative District State Representative Debra Entenman, she received two contributions totaling \$2400 contribution from this PAC on 3/31/2024 (See PDC Report #110208808, attached for staff reference). Yet, when you look at the reporting documents from this PAC, they have yet to report this secret contribution. Weirdly, this Pac did file a C4 report for this time period (See PDC Report # 110205639, attached for staff reference), but this Entenman contribution was nowhere to be found. I will point out that this C4 was filed a bit early and only reported a different \$2400 contribution, however, in order to be compliant, this PAC could easily have filed an amended C4 and not concealed the truth from the public.</p> <p>Let me know if you have any further questions on this one.</p> <p>Best Regards,</p> <p>Glen Morgan</p>
