File a Formal Complaint - Glen Morgan

Glenmorgan89 reported (Tue, 17 Oct at 2:08 PM) via Portal Meta To Whom it May Concern --

It has come to my attention that Jennifer Gregerson, a candidate for Mukilteo City Council, has habitually and willfully committed frequent and multiple violations of **RCW 42.17A.**

1) Failure to file accurate, timely C3 and C4 reports. (Violation of RCW 42.17A.235)

State law requires that candidates and committees file frequent, accurate reports of contributions, expenditures, in-kind contributions, and debt. Unfortunately, Jennifer Gregerson has failed on numerous occasions to do this.

Additionally, Gregerson has illegally failed to disclose any expenditures for her campaign signs. This must be disclosed immediately as either an inkind contribution, expenditure, or debt.

b) Failure to report in-kind contributions.

i) According to the online domain registry for <u>jennifergregerson.com</u> the domain was renewed on 1/23/2017 and likely cost ~\$25. (See attachment).

This expenditure should have been reported on the 2/10/2017 C4, either as a direct expense billed to the campaign, or an in-kind contribution from Gregerson herself. This C4 must be amended immediately to reflect this.

c) Failure to report debt.

i) The expenditure to Boruck Printing for \$794.60 on 3/1/2017 (printing) should have been reported as debt on the February C4, but was not, in violation of state law. The relevant C4 should be immediately amended to accurately show this debt.

ii) The expenditure to Keith Brofsky for \$772.05 on 6/6/2017 should have been reported as debt on the June C4, but was not, in violation of state law. The relevant C4 should be immediately amended to accurately show this debt.

3) Failure to properly break down, describe expenses. (Violation of RCW 42.17A.235, see WAC 390-16-205, WAC 390-16-037)

State law requires that expenditures made on behalf of a candidate or political committee by any person, agency, firm, organization, etc. employed or retained for the purpose of organizing, directing, managing or assisting the candidate's or committee's efforts shall be deemed expenditures by the candidate or committee.

In accordance with **WAC 390-16-037** and **WAC 390-16-205**, such expenditures shall be reported by the candidate or committee as if made or incurred by the candidate or committee directly. Additionally, in accordance with **WAC 390-16-037**, the exact purpose of the expenditure, the quantity of items printed, and the individual value of broadcast ads distributed on various media outlets must be disclosed on form C4.

Despite this requirement in state law, Gregerson failed to identify the number of doorbelling cards she had printed at Boruck Printing and Silkscreen in Seattle for \$794.60 on 3/1/2017 in Seattle. This is a violation of state law.

The C4 covering this time period must immediately be amended to reflect the accurate amount of items printed, pursuant to **WAC 390-16-037.** Please note that she has still not disclosed the number of signs she had printed for her Mayoral race (see attached example of signs). In fact, she has not even disclosed the expenditure at all, in violation of state law.

4) Failure to include sponsor ID. (Violation of RCW 42.17A.320)

State law requires that all political advertisement/independent expenditures contain sponsor identification, which includes the sponsor's name and address. Mediums defined as political advertisement that are required to contain sponsor ID include Facebook pages and advertisements per **WAC 390-05-290**.

Jennifer Gregerson's Facebook page fails to include sponsor identification, in violation of state law. See attachment.

5) Failure to record loan by written instrument, failure to identify lender's occupation, name, city, and state of employer. (Violation of RCW 42.17A.465(2), RCW 42.17A.240)

State law requires that all candidate loans be made with written instrument. Seemingly unable to find donors, Jennifer Gregerson loaned herself \$772.02 on 6/6/2017.

On information and belief, this loan she gave to her campaign was not done by written instrument -- as required by state law. The PDC should immediately subpoena Gregerson's campaign records to determine whether or not she is abiding by this requirement.

Additionally, the C3 Schedule L that identified this loan failed to include the occupation, name, city, and state of employer of Jennifer Gregerson. This must be rectified immediately by amending the report.

6) Failure to accurately disclose ownership of a PERS retirement account as an asset. (Violation of RCW 42.17A.700, see WAC 390-24-010)

State law requires that candidates and elected officials disclose the assets that they own on their F1 personal finance affairs statement, if they are over a certain value. Gregerson illegally failed to report the value of her PERS retirement account, which is an asset.

The value of Gregerson's PERS retirement account is almost certainly over the statutory reporting threshold of \$2400, as she is the longtime Mukilteo Mayor. In her capacity in this position, she is required to pay into the PERS system.

Gregerson must immediately amend his F1 to show the value of his PERS retirement account.

7) Failure to disclose offices held. (Violation of RCW 42.17A.710, see WAC 390-24-010, 150)

State law requires that elected officials disclose the offices that they hold on corporations and other entities.

Despite this requirement in state law, Gregerson failed to disclose the fact that she is a board member of Domestic Violence Services of Snohomish County and is also a board member of Community Transit. She also failed to disclose the fact that she is Chair of the Alliance for Housing Affordability.

She must resubmit this F1 form immediately to include accurate information.

8) Failure to acknowledge understanding of RCW 42.17A.555. (Violation of RCW 42.17A.700 (7))

State law requires that incumbents for public office check a box on their F1 acknowledging applicable statutes prohibiting misuse of public money for campaign purposes.

Gregerson failed to do this on her 2015 F1. She must resubmit this F1 immediately and acknowledge her understanding of RCW 42.17A.555.

The PDC should investigate the possibility that Jennifer Gregerson committed the above violations maliciously, which would be a class C felony per **RCW 42.17A.750 (2)(c).** If the PDC determines that is the case, they should refer the case to the Attorney General's office for criminal prosecution immediately.
