This report was due on 07/17/2018 and is now 7 weeks late.</p> <p>The candidate has failed to file the 07/16/2018 - 07/30/2018 C4 report. This report was due on 07/31/2018 and is now 5 weeks late.</p> <p>The candidate held a fundraiser 08/22/2018 per her Rollins4PUD Facebook page (see attached) and has failed to report any contributions on a C3 report in the time allowed by statute.</p>
