Subject: Complaint regarding Christine Kilduff, PDC Case 27071

Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on October 25, 2017. Your complaint alleged that Christine Kilduff may have violated RCW 42.17A.235 for failure to timely report contributions and expenditures, and RCW 42.17A.240 for failure to accurately report debts and breakdowns of expenditures.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- Christine Kilduff filed two C-3s on 9/27/16, 1 day beyond the deadline required by RCW 42.17A.235. The C-3 reports disclosed \$58,000 and \$2,000 in contributions respectively.
- The late disclosed reports were minor in comparison to the amount of timely filed reports, the late disclosure did not materially impact the public interest, and Christine Kilduff acknowledged and took responsibility for the non-compliance.
- Christine Kilduff has no prior found violations of PDC laws or rules.

Based on these initial findings, staff has determined that in this instance, failure to timely file the reports of contributions does not amount to an actual material violation warranting further investigation.

PDC staff is reminding Christine Kilduff about the importance of the timely disclosure of all contribution and expenditure activities and the timely filings of all future PDC reports, including the F-1 report.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
