This letter is in response to the Complaint regarding Anonymous Donations in the 2016 Presidential Caucus cycle.

After verifying the 2016 total amount received in anonymous donations, and after identifying some of the March caucus contributors after-the-fact, the amount originally reported as anonymous in the March C3 report will be amended to reflect the revised amount total anonymous contributions received, and the 21<sup>st</sup> LD will pay Washington State Treasurer \$1,399 forfeiting the funds exceeding the \$300 maximum limit .


