Complaint Description
Patriotvikingwoodworking reported via the portal (Wed, 30 Oct 2024 at 9:40 PM) Licensed 501c4 “Ella Adelante” also operating as unregistered “We Are Ella” admits to operations for over 42 months prior to today’s date. Admits to political campaigning, PAC like structure and political consulting with contributions and expenditures having never submitted a proper c-form of any kind in any level for 42 months nor has it properly registered neither as a PAC or a lobbyist firm while admitting to such legislative conduct and political campaigning including campaigning against ballot measures and initiatives and not reporting properly in a jurisdiction of clearly more than 2000 residence. This is a grossly negligent behavior. The public has no access to who the donors have been contributing to this org for 42+ months. The public has no awareness of its expenses on staff, operations, or campaign material or itemized receipts. The public was prevented from being capable of being aware at any point in time how to audit in person anything contribution or expense wise. A greater public offense has occurred here and a flyer was also distributed to over 30,000 residences without proper marking or the top 5 donors present. Entity also made written political threats which requires confidentiality from the PDC to present evidence and attempts to attack city candidates, individual citizens, and city officials for bringing this to the attention of the public and the PDC.

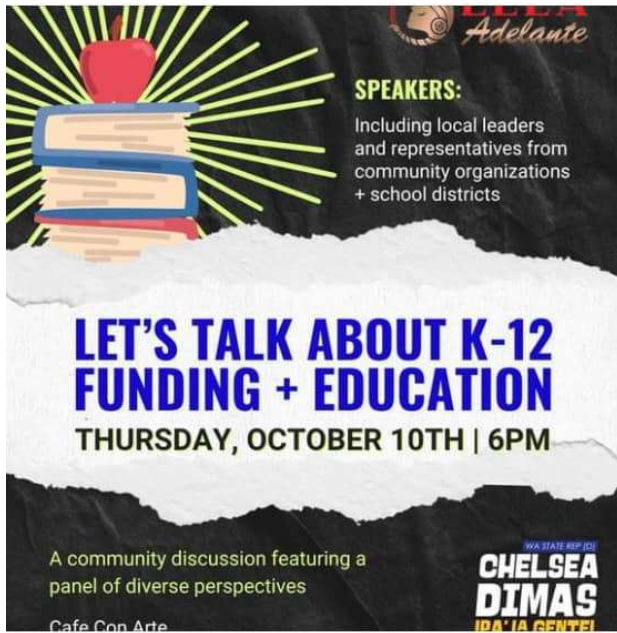
