File a Formal Complaint - Glen Morgan

<u>Glenmorgan89</u> reported (Thu, 12 Oct at 12:51 PM) via Portal Meta To Whom it May Concern --

It has come to my attention that Bob Champion, a candidate for Mukilteo City Council, has habitually and willfully committed frequent and multiple violations of **RCW 42.17A.**

1) Failure to file accurate, timely C3 and C4 reports. (Violation of RCW 42.17A.235)

State law requires that candidates and committees file frequent, accurate reports of contributions, expenditures, in-kind contributions, and debt. Unfortunately, Bob Champion has failed on numerous occasions to do this.

a) Late filed reports:

Additionally, Champion has illegally failed to file ANY C4 report covering the month of May, for which there has clearly been activity. This report must be submitted immediately.

b) Failure to report in-kind contributions.

Bob Champion has illegally failed to report multiple in-kind contributions.

i) According to the Snohomish County Auditor's office, the filing fee for Mukilteo City Council is \$60.00. This was illegally not reported by Champion as an in-kind contribution to his own campaign.

Champion must immediately report this in-kind contribution.

It is clear that a filing fee paid by the candidate himself constitutes an in-kind contribution to his own campaign. In 1974, Attorney General Slade Gorton rendered an official AG opinion on this exact matter, when he wrote, in part:

"In simplest terms, this payment (in those cases in which it is required) is a necessary part of the candidate's financial outlay if he is to have his name appear on the ballot and, in that manner, become eligible to be elected to the office he is seeking. Moreover, the payment is very clearly a transfer of something of value and it cannot be doubted that it is for the purpose of assisting the candidate and furthering his election campaign. Payment of the filing fee is thus precisely within the broad definition of "expenditure" as set forth above."

- ii) According to the online domain registry for www.championformukilteo.com, the domain was renewed on 8/11/2017 and likely cost ~\$25. (See attachment).

This expenditure should have been reported on the 9/11/2017 C4, either as a direct expense billed to the campaign, or an in-kind contribution from Champion himself. This C4 must be amended immediately to reflect this.

iii) According to his C1, Champion is using the campaign management/treasury services of Robert Knoll, a Seattle resident.

Robert Knoll has been paid on numerous occasions for his campaign management/treasury services

(http://web.pdc.wa.gov/MvcQuerySystem/AdvancedSearch/ExpendituresData?spender=ALL&electionYear=ALL&committeeType=IGNORE&vendor=knoll%20robert&page=1). As such, his services have market value, and clearly meet the definition of a "contribution" as described in RCW 42.17A.005.

This being the case, his services must be reported as an in-kind contribution to Champion's campaign. Alternatively, if Knoll is going to be compensated at some future point, this must be reported as debt.

C4s for the relevant time period must be amended to accurately reflect this situation.

- c) Failure to report debt.
- i) The expenditure to Capitol City Press on 7/17/2017 for yard signs (valued at \$590.11) should have been reported as debt on the 21 day pre-primary report, but was not, in violation of state law. The relevant C4 should be immediately amended to accurately show this debt.

2) Illegal use of public resources for campaign purposes. (Violation of RCW 42.17A.555)

State law prohibits the use of public resources on political campaigns. Despite this requirement in state law, Bob Champion illegally used the professional portrait from the City of Mukilteo's website on campaign materials, including his website. See attachment.

This is a clear violation of state law that must be rectified immediately.

3) Failure to properly break down, describe expenses. (Violation of RCW 42.17A.235, see WAC 390-16-205, WAC 390-16-037)

State law requires that expenditures made on behalf of a candidate or political committee by any person, agency, firm, organization, etc. employed or retained for the purpose of organizing, directing, managing or assisting the candidate's or committee's efforts shall be deemed expenditures by the candidate or committee.

In accordance with **WAC 390-16-037** and **WAC 390-16-205**, such expenditures shall be reported by the candidate or committee as if made or incurred by the candidate or committee directly. Additionally, in accordance with **WAC 390-16-037**, the exact purpose of the expenditure, the quantity of items printed, and the individual value of broadcast ads distributed on various media outlets must be disclosed on form C4.

Despite this requirement in state law, Champion illegally failed to report the number of of campaign signs that he ordered from Capitol City Press on 7/17/2017, in violation of state law.

The C4 covering this time period must immediately be amended to reflect the accurate amount of signs purchased, pursuant to **WAC 390-16-037.**

4) Failure to include committee address in Sponsor ID statement. (Violation of RCW 42.17A.320)

On his website, Champion identifies the sponsor as his own committee, however he fails to include the committee's address. He is required to include the address per **RCW 42.17A.320(1)**, which reads, in part: "all written political advertising, whether relating to candidates or ballot propositions, shall include the sponsor's name and address..." [emphasis added]. See attachment.

As this website falls under the category of written political advertisement, the address must be included.

Champion must immediately edit his website to rectify this omission.

5) Failure to record loan by written instrument, failure to identify lender's occupation, name, city, and state of employer. (Violation of RCW 42.17A.465(2), RCW 42.17A.240)

State law requires that all candidate loans be made with written instrument. Seemingly unable to find donors, Bob Champion loaned himself \$5000 on 6/29/2017.

On information and belief, this loan he gave to his campaign was not done by written instrument -- as required by state law. The PDC should immediately subpoena Champion's campaign records to determine whether or not he is abiding by this requirement.

Additionally, the C3 Schedule L that identified this loan failed to include the occupation, name, city, and state of employer of Bob Champion. This must be rectified immediately by amending the report.

6) Failure to accurately disclose ownership of a PERS retirement account as an asset. (Violation of RCW 42.17A.700, see WAC 390-24-010)

State law requires that candidates and elected officials disclose the assets that they own on their F1 personal finance affairs statement, if they are over a certain value. Champion illegally failed to report the value of his PERS retirement account, which is an asset.

The value of Champion's PERS retirement account is almost certainly over the statutory reporting threshold of \$2400, as he is a longtime Mukilteo City Councilman who pays into the PERS system.

Champion must immediately amend his F1 to show the value of his PERS retirement account.

The PDC should investigate the possibility that Bob Champion committed the above violations maliciously, which would be a class C felony per **RCW 42.17A.750 (2)(c).** If the PDC determines that is the case, they should refer the case to the Attorney General's office for criminal prosecution immediately. 
