Report of Investigation

I. Background, Allegations/Complaints, and Response to Complaints

a. Relevant Law

- 1.1 **RCW 42.17A.235 and .240** require political committees to file timely, accurate reports of expenditures made during the period. Under the full reporting option, Campaign Summary Receipts and Expenditures (C-4) reports are required 21 and 7 days before each election in which the committee participates.
- 1.2 **RCW 42.17A.205** defines "participate," with respect to a particular election, as an entity making a monetary or in-kind contribution to a candidate.
- 1.3 **RCW 42.17A.265** requires a political committee to file a special report within 24 hours when it makes a contribution to a single entity that totals \$1,500 or more during the special reporting period between 21 days prior to the election and election day.

b. Complaint

1.4 On Nov. 27, 2024, a complaint was filed with the Public Disclosure Commission (PDC) alleging SEIU Healthcare 1199 NW PAC (the Committee), a continuing political committee, failed to file the required C-4 reports due 21 and 7 days prior to the November 2024 election. (**EXHBIT 1**). Since the Committee participated in the November 2024 election within the

meaning of RCW 42.17A.205, it was required to file C-4 reports on Oct. 15 and Oct. 29, 2024.

c. Response to Complaint

1.5 On Dec. 3, 2024, Han Nguyen, Finance Director of SEIU Healthcare 1199 NW, responded on behalf of the Committee, stating: "Hello, I don't understand. I report the date that listed on the PDC website" and provided the image below from the Committee's PDC reporting program. The listed dates provided by Nguyen correspond to an entity not participating in an election. However, the Committee failed to update its filing status to reflect its participation. If it had done so, the reporting schedule required by RCW 42.17A.235(4) to include the 21-day, 7-day and post-election C-4 reports would be listed on the Committee's PDC filing account.

- 1.6 PDC staff responded to the Committee on Dec. 4, 2024, and clarified the allegation: that the Committee participated in the 2024 General Election and so was required to file C-4 reports pursuant to the expedited schedule established by RCW 42.17A.235(4). PDC Staff provided the Committee with the relevant statutory language. (**EXHIBIT 2**)
- 1.7 On Dec. 20, 2024, the Committee provided an additional written response stating it "denies that it willfully failed to timely file any expenditure reports. 1199NW followed the timelines that are set forth on the SAW webpage in the ORCA 1.501 program. However, 1199NW recognizes that it should have filed the two reports by the deadline, and not relied on the SAW webpage. The Union regrets its error and supports the work of the PDC and its mission. However, as the error was unintentional, the Union requests that a written warning be used as a remedy for this inadvertent violation." (EXHIBIT 3)

d. Initial Hearing (Case Status Review)

1.8 Pursuant to RCW 42.17A.755 and WACs 390-37-060 and 390-37-071, after having conducted a preliminary review and assessment of the complaint alleging that the Committee may have violated RCW 42.17A.235 and .240 by failing to timely and accurately report contributions and expenditures, PDC staff opened a formal investigation and held an Initial Hearing (Case Status Review) on March 18, 2025.

II. Investigative Findings

2.1 The Committee is a continuing political committee that has been registered with the PDC since at least 2008.

- 2.2 As noted by Han Nguyen in response to the initial complaint, the Committee filed C-4 reports each month during the 2024 election year, filing reports covering the previous month on the 10th day (or next business day) of the following month. (**EXHIBIT 4**)
- 2.3 The Committee admits it did not file the 7-day and 21-day preelection C-4 reports as required by RCW 42.17A.235(4).

C-4 Reports filed by the Committee

- 2.4 <u>Campaign Summary Receipts and Expenditures (C-4) Report filed Oct. 2, 2024</u>. The Committee participated in the 2024 General Election, making its first contribution on Sept. 16, 2024 to a candidate participating in 2024 General Election. (**EXHIBIT 5**)
- 2.5 Campaign Summary Receipts and Expenditures (C-4) Report filed Nov. 11, 2024. This report was the tenth C-4 report filed by the Committee during the 2024 election year, listing five expenditures totaling \$432,400. Of these expenditures, three were listed as being paid Oct. 3, 2024, and two were listed as being paid Oct. 21, 2024. The three listed as being made Oct. 3, 2024, were required to be reported by Oct. 15, 2024, but were reported on Nov. 11, 2024, 28 days late, and 7 days after the 2024 General Election. The two listed as being made Oct. 21, 2024, were required to be reported by Oct. 29, 2024, but were reported on Nov. 11, 2024, reported 14 days late, and 7 days after the 2024 General Election. - 2.6 Campaign Summary Receipts and Expenditures (C-4) Report filed Dec. 8, 2024. During its investigation, PDC staff also noted a C-4 report filed Dec. 8, 2024, listed an expenditure relating to the 2024 general election. This report was the eleventh C-4 report filed by the Committee during the 2024 election year, listing a \$2,400 expenditure to Elect Upthegrove paid on Nov. 1, 2024. The report was filed 36 days late and 33 days after the 2024 General Election. (EXHIBIT 7)
- 2.7 As noted, the Committee has been registered with the PDC since at least 2008. PDC records indicate Han Nguyen as the same Committee contact in 2022, where the Committee filed on the correct schedule, timely filing its 21-day and 7-day pre-Primary and its 21-day and 7-day pre-General Election C-4 reports in 2022. (**EXHIBIT 8**)

 - Responses submitted on Dec. 3 and Dec. 20, 2024.

Applicable Statutes and Rules

RCW 42.17A.235 and .240 require candidates, political committees, and continuing political committees to file timely, accurate reports of contributions and expenditures. Under the full reporting option, until five months before the general election, C-4 reports are required monthly when contributions or expenditures exceed \$750 since the last report. C-4 reports are also required 21 and 7 days before each election in which the committee participates and makes expenditures, and in the month following the election.

RCW 42.17A.205 defines "participate" with respect to a particular election, as an entity making a monetary or in-kind contribution to a candidate.

RCW 42.17A.265 requires a political committee to file a special report within 24 hours when it makes a contribution to a single entity that totals \$1,500 or more during the special reporting period between 21 days prior to the election and election day.

Chapter 42.17A RCW

Dear Commissioners:

In accordance with RCW 42.17A.755(1) and RCW 42.17A.775, Let's Go Washington submits the following complaint against SEIU Healthcare 1199 NW PAC, a political committee, for violations of the Fair Campaign Practices Act (FCPA), Chapter 42.17A RCW.

SEIU Healthcare 1199 NW PAC is a continuing political committee. As of today, the committee reported raising \$498,054.84 and expending \$616,245.90 in the 2024 election. The committee first registered on November 27, 2007.

Violation #1: Failure to Timely File 21- & 7-Day Pre-General C4 Report

RCW 42.17A.235(2) provides in relevant part that political committees participating in a particular election must file C4 reports "[o]n the twenty-first day and the seventh day immediately preceding the date on which the election is held." RCW 42.17A.235(2)(a) (emphasis added).

RCW 42.17A.235(4), in turn, provides that the C4 report,

filed twenty-one days before the election shall report all contributions received and expenditures made as of the end of one business day before the date of the report. The report filed seven days before the election shall report all contributions received and expenditures made as of the end of one business day before the date of the report.

(Emphasis added).

Additionally, the FCPA defines "election" as "any primary, general, or special election for public office and any election in which a ballot proposition is submitted to the voters." RCW 42.17A.005(18) (emphasis added).

Finally, RCW 42.17A.005(38)(a) provides that a political committee "participates" in a particular election when it makes a monetary or in-kind contribution to a candidate for that election.

SEIU Healthcare 1199 NW PAC violated the FCPA by failing to timely file a C4 report at the 21-day and seven-day pre-general interval before the November 2024 general election. In accordance with RCW 42.17A.235, these reports were required to have been filed on October 15, 2024 and October 29, 2024 respectively.

Despite this statutory requirement, SEIU Healthcare 1199 NW PAC did not file a C4 report covering this time period until November 11, 2024, well after the election had already ended. This report contained \$432,400.00 worth of expenditures that directly went to support candidates or other political committees during the 2024 general election.

These disclosures were required to be filed *before* the general election but were not filed until *after* the general election.

By failing to disclose this information on time, SEIU Healthcare 1199 NW PAC violated one of the key tenets of the FCPA and RCW 42.17A.235: that the voters are entitled to view campaign finance information about political committees prior to voting.

Conclusion

In light of the above, Let's Go Washington respectfully requests that the PDC investigate SEIU Healthcare 1199 NW PAC's lack of compliance with the FCPA and issue an appropriate enforcement order pursuant to RCW 42.17A.755(1)(b).

Reports filed on the tenth day of the month shall report all contributions received and expenditures made from the closing date of the last report filed through the last day of the month preceding the date of the current report.
