Dear Conner Edwards:

The Public Disclosure Commission (PDC) completed its review of the complaint you filed Nov. 8, 2024. The complaint alleged JamLoop may have violated RCW 42.17A.345 and WAC 390-18-050 for not timely providing its commercial advertiser books of account.

PDC staff reviewed the allegations listed in the complaint; the information submitted with the complaint, the relevant statute(s) and rules, the response to the complaint, and other relevant information to determine whether the record supports a finding of one or more violations.

Based on this review, staff found the following:

- The email address you used to contact JamLoop was not active at the time.
- The company maintains a “Contact Us” form on its website and there was no evidence provided you used this to contact the company.
- In response to PDC staff’s email, JamLoop notified PDC staff the requested records were provided.
