Complaint Description
<p>Brian Wolk reported via the portal (Tue, 8 Apr 2025 at 7:10 PM)</p> <p>On January 8, 2025, Brandon Vollmer publicly declared his candidacy for Tacoma City Council District 5 (CD5) via an X post, stating, "MY NAME IS BRANDON VOLLMER AND I AM RUNNING FOR TACOMA CITY COUNCIL district 5!!!" with a campaign graphic reading "Brandon Vollmer For CD5 'Let's Fix Hosmer'," making him a candidate under Washington law. State law requires candidates to file a Candidate Registration (C-1 report) within two weeks (by January 22, 2025) to disclose campaign organization details, and, since Tacoma CD5 has over 2,000 registered voters, a Personal Financial Affairs Statement (F-1 report) within the same timeframe to disclose financial interests. As of April 8, 2025, Vollmer has not filed either report, violating these requirements. Evidence includes the X post, his X account, and his Facebook account with screenshots attached.</p>
What impact does the alleged violation(s) have on the public?
Deprives the public of transparency regarding Brandon Vollmer's campaign organization and financial interests, hinders Tacoma CD5 voters' ability to make informed decisions, erodes trust in local government, prevents accountability, and unfairly disadvantages compliant candidates, ultimately undermining the integrity of the electoral process and public confidence in governance.
