Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on September 28, 2017. Your complaint alleged that Laurie Dolan may have violated RCW 42.17A.205, RCW 42.17A.235, RCW 42.17A.240, RCW 42.17A.405, RCW 42.17A.700, and RCW 42.17A.710 for not accurately and timely filing candidate registration, contributions, expenditures, and the personal financial affairs assessment.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

The allegations contained in the complaint underlying PDC Case 25901 are substantially similar to a citizen action complaint, filed with the Attorney General's Office pursuant to RCW 42.17A.765.

On April 13, 2018, the PDC became aware that a lawsuit containing substantially similar allegations as the complaint underlying PDC Case 25901 was filed in Superior Court in the name of Washington State.

The Superior Court now has primary jurisdiction over the substance of this complaint; the PDC will defer to their judgment in bringing the issues to resolution.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
