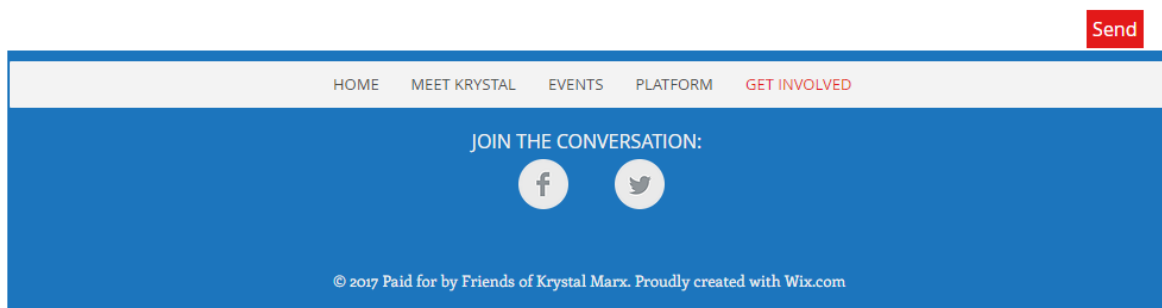
Dear Public Disclosure Commission:

Thank you for the opportunity to respond to the complaint filed by Glen Morgan (case# 25503).

The report that Mr. Morgan references was filed timely, on 5/10/2017 with confirmation number 100760054. It was later amended to include \$43.37 in credit card fees that were accidentally omitted from the report. That report was amended on 6/10/2017. However, the initial report was filed timely and the material change on the amended report was less than \$50.

On his alleged Violation 2, the website has a clear “Paid for by Krystal Marx” disclaimer at the bottom (see screenshot below) and the donate page has the address disclaimer at the bottom. At times when you use web templates it is difficult to hard code changes in pre-set footers so we included address information elsewhere, like on her donate page and included copies of literature on her website that also has proper and full disclaimer information. We understand the PDC is under the process of clarifying disclaimer rules for Facebook pages which has not previously been included in requiring disclaimer information. After consultation with Kurt Young of the PDC recently, we’ve added disclaimer information until they settle the matter.
