To Whom it May Concern –

It has come to my attention that the political committee People for Thurston PAC has violated yet another provision of RCW 42.17A.

1) Failure to report the accurate name, address, and occupational information of a donor. Illegal concealment of donor's true identity. (Violation of RCW 42.17A.240, RCW 42.17A.435, WAC 390-16-037, 390-16-308)

On a recent C3 (submitted 8/11/2017), People for Thurston PAC disclosed a donation of \$5320.00 from Northwest Passage Consulting.

As you can see from the attached documentation, Northwest Passage Consulting is a sole proprietorship owned by Christian Sinderman. As such, this contribution should be attributed solely to Sinderman, per **WAC 390-16-308 (3)**.

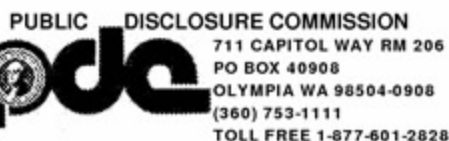
Unfortunately, this did not happen.

The PDC should investigate the possibility that People for Thurston committed the above violations maliciously, which would be a class C felony per **RCW 42.17A.750 (2)(c)**. If the PDC determines that is the case, they should refer the case to the Attorney General's office for criminal prosecution immediately.
