Dear Ms. Townsend,

This letter is in response to the complaint that the Public Disclosure Commission received from Jennifer Davis regarding Jeff Lyon's campaign for Woodinville City Council, known as Lyon for Woodinville City Council.

As an initial matter, the complaint makes no specific allegations against Mr. Lyon. Instead, it vaguely suggests that Mr. Lyon's campaign was supported without reporting by Democratic Woodinville, a political committee with which Mr. Lyon is separately involved. Ms. Davis's insinuations are without merit.

Mr. Lyon's campaign received limited support from Democratic Woodinville, all of which was reported as required by the State's campaign finance laws or which was exempt. Specially, Lyon for Woodinville City Council received only the following in-kind contributions from Democratic Woodinville:
